# A BILL ENTITLED

#### 1 AN ACT concerning

# State Law Library – Renaming

3 FOR the purpose of renaming the State Law Library to be the Thurgood Marshall Law 4 Library; providing that the Thurgood Marshall Law Library is the successor of the  $\mathbf{5}$ State Law Library; providing that certain names and titles of a certain unit and 6 officials in laws and other documents mean the names and titles of the successor unit 7 and officials; providing for the continuity of certain matters and persons; providing 8 that letterhead, business cards, and other documents reflecting the renaming of the 9 Library may not be used until all letterhead, business cards, and other documents already in print and reflecting the name of the Library before the effective date of 1011 this Act are used; requiring the publisher of the Annotated Code, in consultation 12with the Department of Legislative Serves, to correct cross-references and 13 terminology in the Code that are rendered incorrect by this Act; making conforming 14changes; and generally relating to the renaming of the State Law Library.

1 SECTION 2. AND BE IT FURTHER ENACTED, That nothing in this Act affects the 2 term of office of an appointed or elected member of any commission, office, department, 3 agency, or other unit. An individual who is a member of a unit on the effective date of this 4 Act shall remain a member for the balance of the term to which appointed or elected, unless 5 the member sooner dies, resigns, or is removed under provisions of law.

6 SECTION 3. AND BE IT FURTHER ENACTED, That any transaction or 7employment status affected by or flowing from any change of nomenclature or any statute 8 amended by this Act and validly entered into or existing before the effective date of this Act 9 and every right, duty, or interest flowing from a statute amended by this Act remains valid 10 after the effective date of this Act and may be terminated, completed, consummated, or enforced as required or allowed by any statute amended by this Act as though the 11 12amendment had not occurred. If a change in nomenclature involves a change in name or 13designation of any State unit, the successor unit shall be considered in all respects as 14having the powers and obligations granted the former unit.

#### 15 SECTION 4. AND BE IT FURTHER ENACTED, That:

16 (1) the continuity of every commission, office, department, agency or other17 unit is retained; and

18 (2) the personnel, records, files, furniture, fixtures, and other properties 19 and all appropriations, credits, assets, liabilities, and obligations of each retained unit are 20 continued as the personnel, records, files, furniture, fixtures, properties, appropriations, 21 credits, assets, liabilities, and obligations of the unit under the laws enacted by this Act.

SECTION 5. AND BE IT FURTHER ENACTED, That letterhead, business cards, and other documents reflecting the renaming of the State Law Library to be the Thurgood Marshall Law Library may not be used until all letterhead, business cards, and other documents already in print and reflecting the name of the library before the effective date of this Act have been used.

SECTION 6. AND BE IT FURTHER ENACTED, That the publisher of the Annotated Code of Maryland, in consultation with and subject to the approval of the Department of Legislative Services, shall correct, with no further action required by the General Assembly, cross-references and terminology rendered incorrect by this Act. The publisher shall adequately describe any correction made in an editor's note following the section affected.
