CHAPTER _____

1 AN ACT concerning

2 **Agriculture – Nuisance Insects**

3 FOR the purpose of authorizing the Secretary of Agriculture to implement, under certain
4 circumstances, a program to control or eliminate nuisance insects in the State;
5 authorizing the Secretary to carry out a certain project to control or eliminate
6 nuisance insects if the county or municipality in which the nuisance insects are
7 located agrees to pay a certain portion of certain costs; establishing the Nuisance
8 Insects Fund as a special, nonlapsing fund; requiring the Secretary to remit certain
9 payments to the Comptroller for deposit to the Fund; requiring the Secretary or the
10 Secretary's designee to administer the Fund; specifying the contents of the Fund;
11 specifying the purpose for which the Fund may be used; repealing certain provisions
12 of law relating to black fly management and control; authorizing the Secretary to
13 adopt certain regulations; stating a certain finding of the General Assembly; defining
14 certain terms; and generally relating to controlling or eliminating nuisance insects
15 in the State.

7 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
8 That the Laws of Maryland read as follows:

9 **Article – Agriculture**

10 **SUBTITLE 10. NUISANCE INSECTS.**

11 **5–1001.**

12 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS
13 INDICATED.

14 (B) “FUND” MEANS THE NUISANCE INSECTS FUND.

15 (C) (1) “NUISANCE INSECT” MEANS AN INSECT THAT IS DETERMINED BY
16 THE SECRETARY TO PESTER OR ANNOY ONLY HUMANS.

17 (2) “NUISANCE INSECT” DOES NOT INCLUDE AN INSECT THAT IS A
18 THREAT TO THE HEALTH OF HUMANS, ANIMALS, OR PLANTS.

19 **5–1002.**

20 THE GENERAL ASSEMBLY FINDS THAT THE PROLIFERATION OF CERTAIN
21 SPECIES OF INSECTS, INCLUDING THE GROUP *SIMULIUM JENNINGSI*, COMMONLY
22 KNOWN AS BLACK FLIES, WHILE NOT POSING A DIRECT THREAT TO THE HEALTH OF
23 HUMANS, ANIMALS, OR PLANTS, MAY CONSTITUTE A PUBLIC AND COMMON
24 NUISANCE ON LAND AND WATERS USED FOR RECREATION, EMPLOYMENT, AND
25 TOURISM.

26 **5–1003.**

27 (A) (1) SUBJECT TO AVAILABLE FUNDING IN THE STATE BUDGET AND
28 SUBJECT TO SUBSECTION (B) OF THIS SECTION, THE SECRETARY MAY IMPLEMENT
29 A PROGRAM TO CONTROL OR ELIMINATE NUISANCE INSECTS IN THE STATE.

30 (2) TO CARRY OUT THE PROGRAM, THE SECRETARY MAY AUTHORIZE
31 ANY METHOD THE SECRETARY CONSIDERS NECESSARY TO CONTROL OR ELIMINATE

1 NUISANCE INSECTS, INCLUDING THE APPLICATION OF PESTICIDES.

2 (B) (1) THE SECRETARY MAY CARRY OUT A PROJECT TO CONTROL OR
3 ELIMINATE NUISANCE INSECTS UNDER THIS SECTION IF THE COUNTY OR
4 MUNICIPALITY IN WHICH THE NUISANCE INSECTS ARE LOCATED AGREES TO PAY
5 50% OF THE COSTS ASSOCIATED WITH THE PROJECT.

6 (2) THE SECRETARY SHALL REMIT ANY PAYMENT FROM A COUNTY OR
7 MUNICIPALITY RECEIVED UNDER THIS SUBSECTION TO THE COMPTROLLER FOR
8 DEPOSIT TO THE NUISANCE INSECTS FUND, ESTABLISHED UNDER § 5-1004 OF THIS
9 SUBTITLE.

10 5-1004.

11 (A) THERE IS A NUISANCE INSECTS FUND.

12 (B) THE PURPOSE OF THE FUND IS TO FACILITATE THE CONTROL OR
13 ELIMINATION OF NUISANCE INSECTS IN THE STATE.

14 (C) THE SECRETARY OR THE SECRETARY'S DESIGNEE SHALL ADMINISTER
15 THE FUND.

16 (D) (1) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT
17 SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.

18 (2) THE STATE TREASURER SHALL HOLD THE FUND SEPARATELY,
19 AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.

20 (E) THE FUND CONSISTS OF:

21 (1) ANY MONEY DISTRIBUTED TO THE FUND UNDER § 5-1003(B) OF
22 THIS SUBTITLE;

23 (2) MONEY APPROPRIATED IN THE STATE BUDGET TO THE FUND;
24 AND

25 (3) ANY OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED FOR
26 THE BENEFIT OF THE FUND.

27 (F) THE FUND MAY BE USED ONLY TO COVER THE ACTUAL, DOCUMENTED
28 DIRECT AND INDIRECT COSTS ASSOCIATED WITH CONTROLLING OR ELIMINATING
29 NUISANCE INSECTS IN ACCORDANCE WITH A PROGRAM IMPLEMENTED UNDER §
30 5-1003 OF THIS SUBTITLE.

1 **5-1005.**

2 **THE SECRETARY MAY ADOPT REGULATIONS TO IMPLEMENT THIS SUBTITLE.**

3 **Article – Natural Resources**

4 **[Subtitle 22. Black Fly Management and Control.]**

5 **[8-2201.**

6 (a) The General Assembly finds that the proliferation of certain species of the
7 group *Simulium jenningsi*, commonly known as black flies, are a public and common
8 nuisance on land and waters used for recreation, employment, and tourism.

9 (b) It is the intent of the General Assembly that the Department, in conjunction
10 with the Department of Agriculture and the University of Maryland's Department of
11 Entomology, significantly reduce the population of black flies in the State.]

12 **[8-2202.**

13 Subject to funding made available to the Department and the Department of
14 Agriculture to implement the provisions of this subtitle, the Department may, in
15 conjunction with the Department of Agriculture, implement a program to control the spread
16 of black flies in the State.]

17 **[8-2203.**

18 (a) The program shall be implemented initially in Washington County on:

19 (1) State-owned property;

20 (2) Property owned by a local government with consent of the local
21 government; and

22 (3) Private property with consent of the property owner.

23 (b) The Department, in conjunction with the Department of Agriculture and the
24 University of Maryland's Department of Entomology, may:

25 (1) Treat the property with an aerial spraying or backpack spraying of
26 *Bacillus thuringiensis israelensis*;

27 (2) Conduct field studies to determine the need for, location, and timing of
28 spraying;

1 (3) Schedule spraying when the conditions are optimal for ingestion by the
2 black flies;

3 (4) Notify appropriate persons of the date and location of an upcoming
4 spraying;

5 (5) Review the effectiveness of the spraying; and

6 (6) Conduct biomonitoring of aquatic macroinvertebrates and fish in
7 selected streams to ensure there is no impact on the environment.]

8 [8-2204.

9 The Department and the Department of Agriculture may accept, use, or expend any
10 aid, gift, or grant made available from any private or public source to implement the
11 provisions of this subtitle.]

12 [8-2205.

13 The Department may, in conjunction with the Department of Agriculture, adopt
14 regulations to implement the provisions of this subtitle.]

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
16 October 1, 2019.
