18 19 20	WHEREAS, The Korean War was fought in Korea from 1950 to 1953 and involved the North Korean People's Army in conflict with the United States armed forces, allies of the United States, and the Republic of Korea Army; and
21 22 23	WHEREAS, Between June 1950 and July 1953, approximately 5.8 million Americans served in the United States armed forces during the period of the Korean War; and
24	WHEREAS, On July 27, 1953, an armistice was signed ending the war and United

L	WHEREAS, More than 36,000 members of the United States armed forces, including
2	531 from the State of Maryland, lost their lives in Korea; more than 103,000 were wounded;
3	more than 8,200 are listed as missing in action or lost or buried at sea; and more than 7,600
1	are still unaccounted for; and

- WHEREAS, Members of the United States armed forces who served bravely and honorably for the United States during the Korean War returned home to public perception of the war as "The Forgotten War" depriving them of proper appreciation for their patriotic service; and
- WHEREAS, In July 1995 the Korean War Veterans Memorial was dedicated in the District of Columbia, and in May 1990 a memorial was dedicated in Maryland to honor those members of the United States armed forces who died and those who were declared missing in action in the Korean War; and
- WHEREAS, The designation of a "Welcome Home Korean War Veterans Day" is an appropriate way for the State to properly thank and honor its members of the United States armed forces for their service and sacrifice during the Korean War; now, therefore,
- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That Section(s) 7–414 through 7–417, respectively, of Article – General Provisions of the Annotated Code of Maryland be renumbered to be Section(s) 7–415 through 7–418, respectively.
- SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read as follows:

- 23 **7-414.**
- JULY 27 SHALL BE WELCOME HOME KOREAN WAR VETERANS DAY IN RECOGNITION OF THE SERVICE AND SACRIFICE OF KOREAN WAR VETERANS.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2019.
