Economic Development - Baltimore Symphony Orchestra - Funding and Workgroup (*The John C. Merrill Act*)

 $\mathbf{5}$ FOR the purpose of requiring the Governor to appropriate a certain amount of money to 6 the Baltimore Symphony Orchestra in certain fiscal years; establishing the 7 Workgroup on the Baltimore Symphony Orchestra; providing for the composition, 8 chair, and staffing of the Workgroup; prohibiting a member of the Workgroup from 9 receiving certain compensation, but authorizing the reimbursement of certain 10 expenses; requiring the Workgroup to examine and make recommendations 11 regarding certain matters; requiring the Workgroup to report its findings and 12recommendations in a consolidated financial report to certain committees in the

1 may not receive compensation as a member of the Workgroup; but (1) $\mathbf{2}$ (2)is entitled to reimbursement for expenses under the Standard State 3 Travel Regulations, as provided in the State budget. The Workgroup shall: 4 (f) examine structural efficiencies of the Baltimore Symphony Orchestra, $\mathbf{5}$ (1)6 including health care costs and facility usage; and 7 (2)make recommendations regarding: 8 (i) cost containment strategies; and 9 audience development, including: (ii) 1. methods to diversify access to the Baltimore Symphony Orchestra; and 2.methods to increase statewide public participation in the Baltimore Symphony Orchestra. On or before October 1, 2019, the Workgroup shall report its recommendations (g) in a consolidated financial report, in accordance with § 2-1246 of the State Government Article, to the Senate Budget and Taxation Committee and the House of Delegates Appropriations Committee of the General Assembly. SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2019. Section 1 of this Act shall remain effective for a period of 2 years and, at the end of June 30, 2021, Section 1 of this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.
