CHAPTER _____

1 AN ACT concerning

2 **Higher Education – Charles W. Riley Firefighter and Ambulance and Rescue**
3 **Squad Member Scholarship – Alterations**

4 FOR the purpose of repealing a certain requirement for applicants for and recipients of the
5 Charles W. Riley Firefighter and Ambulance and Rescue Squad Member
6 Scholarship; and generally relating to the Charles W. Riley Firefighter and
7 Ambulance and Rescue Squad Member Scholarship.

8 BY repealing and reenacting, with amendments,
9 Article – Education
10 Section 18–603.1
11 Annotated Code of Maryland
12 (2018 Replacement Volume and 2018 Supplement)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Education**

16 18–603.1.

17 (a) (1) In this section the following words have the meanings indicated.

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

1 (2) “Eligible institution” means a public or private nonprofit institution of
2 higher education in the State that possesses a certificate of approval from the Commission.

3 (3) “Fund” means the Charles W. Riley Firefighter and Ambulance and
4 Rescue Squad Member Scholarship Fund.

5 (4) “Scholarship” means the Charles W. Riley Firefighter and Ambulance
6 and Rescue Squad Member Scholarship.

7 (b) There is a Charles W. Riley Firefighter and Ambulance and Rescue Squad
8 Member Scholarship.

9 (c) An individual may apply to the Office for the scholarship if the individual:

10 (1) Is a resident of Maryland;

11 (2) (i) Is accepted for admission or enrolled in the regular
12 undergraduate program at an eligible institution; or

13 (ii) Is accepted for admission or enrolled in a 2–year terminal
14 certificate program in which the course work is acceptable for transfer credit for an
15 accredited baccalaureate program in an eligible institution; and

16 (3) Is actively engaged as a career or volunteer firefighter or ambulance or
17 rescue squad member in an organized fire department or ambulance or rescue squad in the
18 State.

19 (d) A scholarship awarded under this section:

20 (1) May be used for the tuition and mandatory fees at any eligible
21 institution; and

22 (2) May be up to 100% of the equivalent annual tuition and mandatory fees
23 of a resident undergraduate student at the 4–year public institution of higher education
24 within the University System of Maryland, other than the University of Maryland
25 University College and University of Maryland, Baltimore Campus, with the highest
26 annual expenses for a full–time resident undergraduate for courses credited toward a
27 degree in fire service technology, emergency medical technology, fire service management,
28 or public safety administration with a minor or concentration in fire service technology or
29 fire service management.

30 (e) A scholarship recipient shall maintain a grade point average of at least 2.5 on
31 a 4.0 scale.

32 (f) Each recipient of a scholarship under this section may hold the award for 5
33 years of full–time study or 8 years of part–time study.

1 [(g) A scholarship applicant or recipient shall file for federal and State financial
2 aid by March 1 of each year.]

3 [(h) (G) A Senator or Delegate may authorize the Office to award all or a portion
4 of the funds authorized under Subtitles 4 and 5 of this title to eligible recipients of
5 scholarships awarded under this section.

6 [(i) (H) (1) Funds for the Charles W. Riley Firefighter and Ambulance and
7 Rescue Squad Member Scholarship shall be as provided in the annual budget of the
8 Commission by the Governor.

9 (2) There is a Charles W. Riley Firefighter and Ambulance and Rescue
10 Squad Member Scholarship Fund in the Commission.

11 (3) The Commission shall administer the Fund.

12 (4) The Fund is a special, nonlapsing fund that is not subject to § 7-302 of
13 the State Finance and Procurement Article.

14 (5) The State Treasurer shall hold the Fund separately and the
15 Comptroller shall account for the Fund.

16 (6) The Commission:

17 (i) May accept any gift or grant from any person or corporation for
18 the Fund;

19 (ii) Shall use any gift or grant that it receives for a scholarship from
20 the Fund; and

21 (iii) Shall deposit any gift or grant that it receives for the Fund with
22 the State Treasurer.

23 (7) (i) At the end of the fiscal year, the Commission shall prepare an
24 annual report on the Fund that includes an accounting of all financial receipts and
25 expenditures to and from the Fund.

26 (ii) The Commission shall submit a copy of the report to the General
27 Assembly in accordance with § 2-1246 of the State Government Article.

28 [(j) (I) A recipient of a scholarship shall work for at least 1 year as a volunteer
29 or career firefighter or ambulance or rescue squad member in an organized fire department
30 or ambulance or rescue squad in the State after completion of an eligible program in an
31 eligible institution.

32 [(k) (J) A scholarship recipient shall repay the Commission the funds received

1 under this section if the recipient does not perform the service obligation required under
2 subsection [(j)] (I) of this section.

3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
4 October 1, 2019.
