# 1 AN ACT concerning

# Public Health - Disposition of Remains - Forfeiture or Waiver of Right of Disposition

4 FOR the purpose of adding an adult grandchild of a certain decedent to the list of persons who have the right to arrange for the final disposition of the body of the decedent;  $\mathbf{5}$ 6 requiring a person to forfeit the right of final disposition of the body of a decedent 7 and that the right pass to the next qualifying person under certain circumstances; 8 providing that a certain person's right of disposition may be restored under certain 9 circumstances; authorizing a person to waive the right of final disposition and 10 requiring the right to pass to the next qualifying person under certain circumstances; prohibiting funeral directors, morticians, and funeral establishments from being 11 12held civilly liable for acting in reliance on this Act; providing for the construction of
