- 24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 25 That the Laws of Maryland read as follows:

## **Article - State Personnel and Pensions**

- 1 23-215.1.
- 2 (a) This section applies to a member who:
- 3 (1) on or before June 30, 2011, is subject to the Alternate Contributory 4 Pension Selection:
- 5 (2) (i) is separated from employment for 4 years or less;
- 6 (ii) 1. is separated from employment [for more than 4 years] for 7 military service that meets the requirements of the federal Uniformed Services 8 Employment and Reemployment Rights Act; and
- 9 2. resumes employment within 1 year of leaving military 10 service in a position that is included in the Employees' Pension System or Teachers' Pension 11 System; or
- 12 (iii) [1. is separated from employment for more than 4 years; and
- 2. on or before June 30, 2011, accrues] IS SEPARATED FROM
  EMPLOYMENT WITH the minimum eligibility service needed to be eligible for a vested
  allowance in the Alternate Contributory Pension Selection under Title 29, Subtitle 3 of this
  article;
- 17 (3) does not withdraw the member's accumulated contributions; and
- 18 (4) does not become a retiree.
- 19 (b) A member described in subsection (a) of this section who resumes employment 20 in a position that is included in the Employees' Pension System or Teachers' Pension 21 System, shall resume participation in the Alternate Contributory Pension Selection if the 22 employer participates in the Alternate Contributory Pension Selection.

## SECTION 2. AND BE IT FURTHER ENACTED, That:

- 24 (a) This Act shall be construed to apply retroactively and shall be applied to and 25 interpreted to affect an individual who meets the requirements of this Act and who resumed 26 employment in a position included in the Employees' Pension System or Teachers' Pension 27 System on or after July 1, 2011.
- 28 (b) Any service credit earned under the Reformed Contributory Pension Benefit 29 by an individual who meets the requirements of this Act shall be credited to the member or 30 former member in the Alternate Contributory Pension Selection if the member or former 31 member has not withdrawn the member's accumulated contributions.
- 32 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July 33 1, 2019.
