2 **Public Health – Prescription Drug Monitoring Program – Revisions**

3 FOR the purpose of requiring, instead of authorizing, the Prescription Drug Monitoring
4 Program to review prescription monitoring data for indications of a possible misuse
5 or abuse of a monitored prescription drug; requiring, instead of authorizing, the
6 Program to report the possible misuse or abuse to the prescriber or dispenser of the
7 monitored prescription drug under certain circumstances; requiring the Program to
8 provide education to the prescriber or dispenser of the monitored prescription drug
9 under certain circumstances; requiring, instead of authorizing, the Program to
10 review prescription monitoring data for indications of a possible violation of law or a
11 possible breach of professional standards by a prescriber or a dispenser; requiring,
12 instead of authorizing, the Program to notify the prescriber or dispenser of the
13 possible violation of law or possible breach of professional standards and provide
14 education to the prescriber or dispenser; authorizing the Program, under certain
15 circumstances, to provide prescription monitoring data to the Office of Controlled
16 Substances Administration for a certain purpose; requiring the Program, under
17 certain circumstances, to provide a certain notification to certain prescribers or
18 dispensers; requiring the Program to take into account certain factors in making a
19 certain determination; ~~prohibiting the obtaining of certain guidance and
20 interpretation from the technical advisory committee from delaying the reporting of
21 a possible violation of law or a possible breach of professional standards to the Office
22 of Controlled Substances Administration under certain circumstances;~~ authorizing
23 the Program to refer a certain violation of law or a certain breach of professional

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

23 That the Laws of Maryland read as follows:

24 **Article – Health – General**

25 21–2A–01.

26 (a) In this subtitle the following words have the meanings indicated.

27 (b) “Board” means the Advisory Board on Prescription Drug Monitoring.

28 (c) (1) “Dispense” has the meaning stated in § 12–101 of the Health
 29 Occupations Article.

30 (2) “Dispense” does not include:

31 (i) Directly administering a monitored prescription drug to a
 32 patient; or

33 (ii) Giving out prescription drug samples.

1 (d) (1) “Dispenser” means a person authorized by law to dispense a monitored
2 prescription drug to a patient or the patient’s agent in the State.

3 (2) “Dispenser” includes a nonresident pharmacy.

4 (3) “Dispenser” does not include:

5 (i) A licensed hospital pharmacy that only dispenses a monitored
6 prescription drug for direct administration to an inpatient of the hospital;

7 (ii) An opioid treatment services program;

8 (iii) A veterinarian licensed under Title 2, Subtitle 3 of the
9 Agriculture Article when prescribing controlled substances for animals in the usual course
10 of providing professional services;

11 (iv) A pharmacy issued a waiver permit under COMAR 10.34.17.03
12 that provides pharmaceutical specialty services exclusively to persons living in assisted
13 living facilities, comprehensive care facilities, and developmental disabilities facilities; and

14 (v) A pharmacy that:

15 1. Dispenses medications to an inpatient hospice; and

16 2. Has been granted a waiver under § 21–2A–03(f) of this
17 subtitle.

18 (e) “Licensing entity” means an entity authorized under the Health Occupations
19 Article to license, regulate, or discipline a prescriber or dispenser.

20 (f) “Monitored prescription drug” means a prescription drug that contains a
21 Schedule II, Schedule III, Schedule IV, or Schedule V controlled dangerous substance
22 designated under Title 5, Subtitle 4 of the Criminal Law Article.

23 **(G) “OFFICE” MEANS THE OFFICE OF CONTROLLED SUBSTANCES**
24 **ADMINISTRATION IN THE DEPARTMENT.**

25 **[(g)] (H) “Opioid treatment services program” means a program that:**

26 (1) Is certified in accordance with § 8–401 of this article or licensed by the
27 State under § 7.5–401 of this article;

28 (2) Is authorized to treat patients with opioid dependence with a
29 medication approved by the federal Food and Drug Administration for opioid dependence;

30 (3) Complies with:

1 (i) The Code of Federal Regulations 42, Part 8;

2 (ii) COMAR 10.47.02.11; and

3 (iii) Requirements for the secure storage and accounting of opioid
4 medication imposed by the federal Drug Enforcement Administration and the [State] Office
5 [of Controlled Substances Administration]; and

6 (4) Has been granted a certification for operation by the Department, the
7 federal Substance Abuse and Mental Health Services Administration, and the federal
8 Center for Substance Abuse Treatment.

9 **[(h)] (I)** “Pharmacist” means an individual who is licensed under Title 12 of the
10 Health Occupations Article to dispense a monitored prescription drug.

11 **[(i)] (J)** “Pharmacist delegate” means an individual who is:

12 (1) Authorized by a registered pharmacist to request or access prescription
13 monitoring data; and

14 (2) Employed by or under contract with the same professional practice as
15 the registered pharmacist.

16 **[(j)] (K)** “Prescriber” means a licensed health care professional authorized by
17 law to prescribe a monitored prescription drug.

18 **[(k)] (L)** “Prescriber delegate” means an individual who is:

19 (1) Authorized by a registered prescriber to request or access prescription
20 monitoring data; and

21 (2) Employed by or under contract with the same professional practice as
22 the prescriber.

23 **[(l)] (M)** “Prescription drug” has the meaning stated in § 21–201 of this title.

24 **[(m)] (N)** “Prescription monitoring data” means the information submitted to the
25 Program for a monitored prescription drug.

26 **[(n)] (O)** “Program” means the Prescription Drug Monitoring Program
27 established under this subtitle.

28 **[(o)] (P)** “Registered” means registered with the Program to request or access
29 prescription monitoring data for clinical use.

1 ~~[(p)]~~ (Q) “Terminal illness” means a medical condition that, within reasonable
2 medical judgment, involves a prognosis for a patient that likely will result in the patient’s
3 death within 6 months.

5 (a) There is a Prescription Drug Monitoring Program in the Department.

6 21–2A–04.

7 (a) The Secretary, in consultation with the Board, shall adopt regulations to carry
8 out this subtitle.

9 (b) The regulations adopted by the Secretary shall:

10 (1) Specify the prescription monitoring data required to be submitted
11 under § 21–2A–03 of this subtitle;

12 (2) Specify the electronic or other means by which information is to be
13 submitted:

14 (i) Without unduly increasing the workload and expense on
15 dispensers; and

16 (ii) In a manner as compatible as possible with existing data
17 submission practices of dispensers;

18 (3) Specify that the information be submitted by dispensers once every 24
19 hours;

20 (4) Specify that the Program:

21 (i) Shall provide the information technology software to dispensers
22 necessary to upload prescription drug monitoring data to the Program; and

23 (ii) May not impose any fees or other assessments on prescribers or
24 dispensers to support the operation of the Program;

25 (5) Identify the mechanism by which prescription monitoring data are
26 disclosed to a person, in accordance with § 21–2A–06 of this subtitle;

27 (6) Identify the circumstances under which a person may disclose
28 prescription monitoring data received under the Program;

29 (7) Specify the process for the Program’s review of prescription monitoring
30 data and reporting of:

1 (i) Possible misuse or abuse of a monitored prescription drug under
2 § 21-2A-06(c) of this subtitle; or

3 (ii) A possible violation of law or possible breach of professional
4 standards under § 21-2A-06(d) of this subtitle;

5 (8) Establish requirements for Program retention of prescription
6 monitoring data for 3 years; and

7 (9) Require that:

8 (i) Confidential or privileged patient information be kept
9 confidential; and

10 (ii) Records or information protected by a privilege between a health
11 care provider and a patient, or otherwise required by law to be held confidential, be filed in
12 a manner that, except as otherwise provided in § 21-2A-06 of this subtitle, does not disclose
13 the identity of the person protected.

16 (1) Meet not fewer than three times annually;

17 (2) Make recommendations to the Secretary relating to the design and
18 implementation of the Program, including recommendations relating to:

19 (i) Regulations;

20 (ii) Legislation; and

21 (iii) Sources of funding, including grant funds under the Harold
22 Rogers Prescription Drug Monitoring Program and other sources of federal, private, or
23 State funds;

24 (3) Provide annually to the Governor and, in accordance with § 2-1246 of
25 the State Government Article, the General Assembly a report that includes:

26 (i) The number of prescribers and prescriber delegates registered
27 with and using the Program;

28 (ii) The number of pharmacists and pharmacist delegates registered
29 with and using the Program;

30 (iii) The number of disclosures made to federal law enforcement
31 agencies or State or local law enforcement agencies;

1 (iv) An analysis of the impact of the Program on patient access to
2 pharmaceutical care and on curbing prescription drug diversion in the State; [and]

3 (V) 1. THE NUMBER OF PROVIDERS, BY PROVIDER TYPE,
4 WHO RECEIVED OUTREACH AND EDUCATION FROM THE PROGRAM; AND

5 2. THE NUMBER OF CASES FOR WHICH THE PROVIDERS
6 RECEIVED OUTREACH AND EDUCATION FROM THE PROGRAM;

7 (VI) 1. THE NUMBER OF CASES THAT WERE IDENTIFIED FOR
8 TECHNICAL ADVISORY COMMITTEE REVIEW BEFORE REFERRAL TO THE OFFICE;
9 AND

10 2. THE NUMBER OF PROVIDERS, BY PROVIDER TYPE,
11 INVOLVED IN THE CASES;

12 (VII) 1. THE NUMBER OF CASES THAT WERE REFERRED TO
13 THE OFFICE FOR FURTHER EVALUATION AND THE OUTCOMES OF THE OFFICE
14 EVALUATIONS; AND

15 2. THE NUMBER OF PROVIDERS, BY PROVIDER TYPE,
16 INVOLVED IN THE CASES; AND

17 [(v)] (VIII) Any recommendations related to modification or
18 continuation of the Program; and

19 (4) Provide ongoing advice and consultation on the implementation and
20 operation of the Program, including recommendations relating to:

21 (i) Changes in the Program to reflect advances in technology and
22 best practices in the field of electronic health records and electronic prescription
23 monitoring;

24 (ii) Changes to statutory requirements; and

25 (iii) The design and implementation of an ongoing evaluation
26 component of the Program.

28 (a) Prescription monitoring data:

29 (1) Are confidential and privileged, and not subject to discovery, subpoena,
30 or other means of legal compulsion in civil litigation;

1 (2) Are not public records; and

2 (3) Except as provided in subsections (b), (c), (d), and (f) of this section or
3 as otherwise provided by law, may not be disclosed to any person.

4 (b) The Program shall disclose prescription monitoring data, in accordance with
5 regulations adopted by the Secretary, to:

6 (1) A prescriber, or a licensed health care practitioner authorized by the
7 prescriber, in connection with the medical care of a patient;

8 (2) A dispenser, or a licensed health care practitioner authorized by the
9 dispenser, in connection with the dispensing of a monitored prescription drug;

10 (3) A federal law enforcement agency or a State or local law enforcement
11 agency, on issuance of a subpoena, for the purpose of furthering an existing bona fide
12 individual investigation;

13 (4) The State Board of Physicians, on issuance of an administrative
14 subpoena voted on by a quorum of a disciplinary panel, as defined in § 14–101 of the Health
15 Occupations Article, for the purposes of furthering an existing bona fide investigation of an
16 individual;

17 (5) A licensing entity other than the State Board of Physicians, on issuance
18 of an administrative subpoena voted on by a quorum of the board of the licensing entity,
19 for the purposes of furthering an existing bona fide individual investigation;

20 (6) A rehabilitation program under a health occupations board, on issuance
21 of an administrative subpoena;

22 (7) A patient with respect to prescription monitoring data about the
23 patient;

24 (8) Subject to subsection (i) of this section, the authorized administrator of
25 another state's prescription drug monitoring program;

26 (9) The following units of the Department, on approval of the Secretary, for
27 the purpose of furthering an existing bona fide individual investigation:

28 (i) The Office of the Chief Medical Examiner;

29 (ii) The Maryland Medical Assistance Program;

30 (iii) The Office of the Inspector General;

31 (iv) The Office of Health Care Quality; and

1 (v) ~~The Office of Controlled Substances Administration;~~

2 (10) The technical advisory committee established under § 21–2A–07 of this
3 subtitle for the purposes set forth in subsections (c), (d), and (e) of this section; or

4 (11) The following entities, on approval of the Secretary and for the purpose
5 of furthering an existing bona fide individual case review:

6 (i) The State Child Fatality Review Team or a local child fatality
7 review team established under Title 5, Subtitle 7 of this article, on request from the chair
8 of the State or local team;

9 (ii) A local drug overdose fatality review team established under §
10 5–902 of this article, on request from the chair of the local team;

11 (iii) The Maternal Mortality Review Program established under §
12 13–1203 of this article, on request from the Program; and

13 (iv) A medical review committee described in § 1–401(b)(3) of the
14 Health Occupations Article, on request from the committee.

15 (c) (1) In accordance with regulations adopted by the Secretary:

16 (i) The Program [may] **SHALL** review prescription monitoring data
17 for indications of possible misuse or abuse of a monitored prescription drug; and

18 (ii) If the Program’s review of prescription monitoring data indicates
19 possible misuse or abuse of a monitored prescription drug, the Program [may report]
20 **SHALL:**

21 **1. REPORT** the possible misuse or abuse to the prescriber or
22 dispenser of the monitored prescription drug; **AND**

23 **2. PROVIDE EDUCATION TO THE PRESCRIBER OR**
24 **DISPENSER.**

25 (2) Before the Program reports the possible misuse or abuse of a monitored
26 prescription drug to a prescriber or dispenser under this subsection, the Program may
27 obtain from the technical advisory committee:

28 (i) Clinical guidance regarding indications of possible misuse or
29 abuse; and

30 (ii) Interpretation of the prescription monitoring data that indicates
31 possible misuse or abuse.

1 (d) (1) In accordance with regulations adopted by the Secretary **AND SUBJECT**
 2 **TO PARAGRAPH (3) OF THIS SUBSECTION**, the Program [may] **SHALL** review
 3 prescription monitoring data for indications of a possible violation of law or a possible
 4 breach of professional standards by a prescriber or a dispenser.

5 (2) [Subject to paragraph (3) of this subsection, if] **IF** the Program's review
 6 indicates a possible violation of law or a possible breach of professional standards by a
 7 prescriber or a dispenser, the Program [may]:

8 (i) 1. [Notify] **SHALL NOTIFY** the prescriber or dispenser of the
 9 possible violation of law or possible breach of professional standards; and

10 [(ii)] 2. [Provide] **SHALL PROVIDE** education to the prescriber or
 11 dispenser; **AND**

12 (ii) ~~1. MAY SUBJECT TO PARAGRAPH (4) OF THIS~~
 13 ~~SUBSECTION, MAY PROVIDE PRESCRIPTION MONITORING DATA TO THE OFFICE OF~~

20 (3) (I) Before the Program provides notification of a possible violation
 21 of law or a possible breach of professional standards to a prescriber or a dispenser, the
 22 Program shall obtain from the technical advisory committee:

23 [(i)] 1. Clinical guidance regarding ~~indications of~~ **METHODS**
 24 **USED TO IDENTIFY** a possible violation of law or a possible breach of professional
 25 standards; and

26 [(ii)] 2. Interpretation of the prescription monitoring data [that
 27 indicates] ~~SUFFICIENT TO ADVISE ON~~ **ADVISING** WHETHER THE METHOD IDENTIFIES
 28 a possible violation of law or a possible breach of professional standards.

29 (II) **IN DETERMINING WHETHER ITS REVIEW INDICATES A**
 30 **POSSIBLE VIOLATION OF LAW OR A POSSIBLE BREACH OF PROFESSIONAL**
 31 **STANDARDS BY A PRESCRIBER OR DISPENSER, THE PROGRAM SHALL TAKE INTO**
 32 **ACCOUNT TO THE EXTENT PRACTICABLE THE PARTICULAR SPECIALTY,**
 33 **CIRCUMSTANCES, PATIENT TYPE, AND LOCATION OF THE PRESCRIBER OR**
 34 **DISPENSER.**

~~(H) OBTAINING CLINICAL GUIDANCE AND INTERPRETATION OF PRESCRIPTION MONITORING DATA FROM THE TECHNICAL ADVISORY COMMITTEE MAY NOT DELAY REPORTING OF A POSSIBLE VIOLATION OF LAW OR A POSSIBLE BREACH OF PROFESSIONAL STANDARDS TO THE OFFICE OF CONTROLLED SUBSTANCES ADMINISTRATION IF, IN THE JUDGMENT OF THE PROGRAM, A DELAY COULD RESULT IN DANGER TO PUBLIC HEALTH OR PUBLIC SAFETY.~~

(4) (I) IF METHODS DEVELOPED UNDER PARAGRAPH (3)(I) OF THIS SUBSECTION INDICATE A POSSIBLE VIOLATION OF LAW OR A POSSIBLE BREACH OF PROFESSIONAL STANDARDS AND THE PROGRAM DETERMINES THAT OUTREACH AND EDUCATION TO THE PRESCRIBER OR DISPENSER IS INADEQUATE TO ADDRESS THE POSSIBLE BREACH OR VIOLATION, THE PROGRAM MAY REFER THE POSSIBLE VIOLATION OF LAW OR A POSSIBLE BREACH OF PROFESSIONAL STANDARDS ALONG WITH PRESCRIPTION MONITORING DATA TO THE OFFICE FOR FURTHER INVESTIGATION, PROVIDED THAT THE PROGRAM:

1. PROVIDES NOTICE AND AN OPPORTUNITY TO THE TECHNICAL ADVISORY COMMITTEE TO MAKE RECOMMENDATIONS WITHIN 10 BUSINESS DAYS REGARDING INTERPRETATION OF THE DATA;

2. PROVIDES THE RECOMMENDATIONS OF THE TECHNICAL ADVISORY COMMITTEE, IF ANY, TO THE OFFICE; AND

3. NOTIFIES THE PRESCRIBER OR THE DISPENSER THAT THE PRESCRIPTION MONITORING DATA WILL BE PROVIDED TO THE OFFICE FOR FURTHER INVESTIGATION.

1 (a) There is a technical advisory committee to the Program.

2 (b) The purpose of the technical advisory committee is to:

3 (1) Review requests for information from the Program under §
4 21-2A-06(b)(3), (4), (5), (6), (8), or (9) of this subtitle; and

5 (2) Provide clinical guidance and interpretation to the Program regarding
6 indications of possible misuse or abuse of a monitored prescription drug or a possible
7 violation of law or a possible breach of professional standards by a prescriber or a dispenser
8 under § 21-2A-06(c) and (d) of this subtitle.

9 SECTION 2. AND BE IT FURTHER ENACTED, That it is the intent of the General
10 Assembly that the Prescription Drug Monitoring Program shall continue to work with the
11 Program's technical advisory committee to further refine and enhance the quality of the
12 algorithms and other data tools to identify possible ~~or probable~~ violations of law and
13 breaches of professional standards.

15 October 1, 2019.
