Vehicle Laws - Intersections - Prohibited Acts

- 3 FOR the purpose of prohibiting a vehicle from entering certain intersections when facing certain traffic signals if the vehicle is unable to safely and completely proceed 4 5 through the intersection; establishing certain exceptions to the prohibition; 6 prohibiting a police officer from issuing a citation for a violation of this Act unless 7 certain conditions are met; establishing a certain fine for a violation of this Act; 8 providing that a violation of this Act is not a moving violation for certain purposes; 9 making conforming changes; and generally relating to prohibited acts by vehicles at intersections. 10

- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

- 20 (a) (1) Except for special pedestrian signals that carry a legend, where traffic 21 is controlled by traffic control signals that show different colored lights or colored lighted 22 arrows, whether successively one at a time or in combination, only the colors green, red, 23 and yellow may be used.
- 24 (2) These lights apply to drivers and pedestrians as provided in this 25 section.

1 2 3	(b) [Vehicular] SUBJECT TO SUBSECTION (M) OF THIS SECTION, VEHICULAR traffic facing a circular green signal may proceed straight through or, unless a sign at the place prohibits the turn, turn right or left.

- 1 (2) (I) A VEHICLE THAT IS MAKING A LEFT TURN WHEN FACING A
 2 CIRCULAR GREEN SIGNAL MAY ENTER THE INTERSECTION WHILE YIELDING THE
 3 RIGHT-OF-WAY TO ANY OTHER VEHICLE THAT IS APPROACHING FROM THE
 4 OPPOSITE DIRECTION OR TO A PEDESTRIAN.
- 5 (II) A VEHICLE THAT IS MAKING A RIGHT TURN MAY ENTER THE 6 INTERSECTION WHILE YIELDING THE RIGHT-OF-WAY TO A PEDESTRIAN OR A 7 BICYCLIST.

- [(m)] (N) Except for those provisions of this section that by their very nature cannot apply, this section applies to a traffic control signal placed at a location other than an intersection. Each stop required by the signal shall be made at a sign or marking on the pavement indicating where the stop shall be made or, if there is no sign or marking, at the signal.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2019.
