Hospitals - Patient's Bill of Rights

- 3 FOR the purpose of requiring each administrator of a hospital to provide patients with a 4 certain patient's bill of rights; requiring each administrator of a hospital to provide 5 certain patients with a translator, an interpreter, or another accommodation to 6 provide certain assistance to patients; requiring each administrator of a hospital to 7 conspicuously post copies of the patient's bill of rights on the hospital's website and 8 in areas of the hospital accessible to patients; requiring each administrator of a 9 hospital to provide annual training to certain staff members to ensure the staff's 10 knowledge and understanding of the patient's bill of rights; requiring a certain 11 statement to be written in plain language; altering the rights that are required to be 12 included in a patient's bill of rights; requiring the Office of Health Care Quality to 13 monitor certain compliance; requiring the Office to report to the General Assembly on or before a certain date each year; declaring the intent of the General Assembly; 14 15 defining a certain term; making a technical change; and generally relating to 16 hospitals and a patient's bill of rights.

- 22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 23 That the Laws of Maryland read as follows:

- 1 (A) IN THIS SECTION, "PATIENT" INCLUDES AN INPATIENT, AN OUTPATIENT, 2 AND AN EMERGENCY SERVICES PATIENT.
- 3 (B) THE GENERAL ASSEMBLY INTENDS TO PROMOTE THE HEALTH, SAFETY,
 4 AND WELL-BEING OF PATIENTS AND TO FOSTER BETTER COMMUNICATION
 5 BETWEEN PATIENTS AND HEALTH CARE PROVIDERS IN HOSPITALS THROUGH THE
 6 USE OF A PATIENT'S BILL OF RIGHTS THAT SPECIFIES THE ETHICAL AND HUMANE
 7 TREATMENT THE PATIENT HAS A RIGHT TO EXPECT.
- 8 [(a)] (C) Each administrator of a hospital [is responsible for making available] 9 SHALL:
- 10 **(1) PROVIDE** to each patient in the hospital a **WRITTEN** copy of the patient's bill of rights that [the]:
- 12 (I) THE hospital adopts under [the] Joint Commission [on 13 Accreditation of Hospitals'] guidelines; AND
- 14 (II) COMPLIES WITH SUBSECTION (D) OF THIS SECTION;
- 15 (2) If a patient does not speak English, requires the 16 patient's bill of rights in an alternative format, or is illiterate, 17 provide a translator, an interpreter, or another accommodation to 18 assist the patient in understanding and exercising the rights included
- 19 IN THE PATIENT'S BILL OF RIGHTS;
- 20 (3) CONSPICUOUSLY POST COPIES OF THE PATIENT'S BILL OF RIGHTS
 21 ON THE HOSPITAL'S WEBSITE AND IN AREAS OF THE HOSPITAL ACCESSIBLE TO
 22 PATIENTS, INCLUDING THE ADMITTING OFFICE, PATIENT FLOORS, PATIENT ROOMS,
 23 THE OUTPATIENT DEPARTMENT, AND EMERGENCY SERVICES WAITING AREAS; AND
- 24 (4) PROVIDE ANNUAL TRAINING TO ALL PATIENT CARE STAFF 25 MEMBERS TO ENSURE THE STAFF'S KNOWLEDGE AND UNDERSTANDING OF THE 26 PATIENT'S BILL OF RIGHTS.
- [(b)] (D) The patient's bill of rights shall AT A MINIMUM include a statement, IN PLAIN LANGUAGE, that a patient has a right to [expect and receive appropriate assessment, management, and treatment of pain as an integral component of the patient's care]:
- 31 (1) RECEIVE CONSIDERATE, RESPECTFUL, AND COMPASSIONATE 32 CARE;

- 1 (2) BE PROVIDED CARE IN A SAFE ENVIRONMENT FREE FROM ALL
- 2 FORMS OF ABUSE AND NEGLECT, INCLUDING VERBAL, MENTAL, PHYSICAL, AND
- 3 SEXUAL ABUSE;
- 4 (3) HAVE A MEDICAL SCREENING EXAM AND BE PROVIDED
- 5 STABILIZING TREATMENT FOR EMERGENCY MEDICAL CONDITIONS AND LABOR;
- 6 (4) BE FREE FROM RESTRAINTS AND SECLUSION UNLESS NEEDED
- 7 FOR SAFETY;
- 8 (5) BE TOLD THE NAMES AND JOBS OF THE HEALTH CARE TEAM
- 9 MEMBERS INVOLVED IN THE PATIENT'S CARE;
- 10 (6) HAVE RESPECT SHOWN FOR THE PATIENT'S PERSONAL VALUES,
- 11 BELIEFS, AND WISHES;
- 12 (7) BE TREATED WITHOUT DISCRIMINATION BASED ON RACE, COLOR,
- 13 NATIONAL ORIGIN, ETHNICITY, AGE, GENDER, SEXUAL ORIENTATION, GENDER
- 14 IDENTITY OR EXPRESSION, PHYSICAL OR MENTAL DISABILITY, RELIGION,
- 15 LANGUAGE, OR ABILITY TO PAY;
- 16 (8) BE PROVIDED A LIST OF PROTECTIVE AND ADVOCACY SERVICES
- 17 WHEN NEEDED;
- 18 (9) RECEIVE INFORMATION ABOUT THE PATIENT'S HOSPITAL AND
- 19 PHYSICIAN CHARGES AND ASK FOR AN ESTIMATE OF HOSPITAL CHARGES BEFORE
- 20 CARE IS PROVIDED;
- 21 (10) RECEIVE INFORMATION IN A MANNER THAT IS UNDERSTANDABLE
- 22 BY THE PATIENT, WHICH MAY INCLUDE:
- 23 (I) SIGN AND FOREIGN LANGUAGE INTERPRETERS;
- 24 (II) ALTERNATIVE FORMATS, INCLUDING LARGE PRINT,
- 25 BRAILLE, AUDIO RECORDINGS, AND COMPUTER FILES; AND
- 26 (III) VISION, SPEECH, HEARING, AND OTHER AIDS AS NEEDED,
- 27 WITHOUT CHARGE;
- 28 (11) RECEIVE INFORMATION FROM THE PATIENT'S DOCTOR OR
- 29 HEALTH CARE TEAM MEMBER ABOUT THE PATIENT'S DIAGNOSIS, PROGNOSIS, TEST
- 30 RESULTS, POSSIBLE OUTCOMES OF CARE, AND UNANTICIPATED OUTCOMES OF
- 31 **CARE**;
