CHAPTER _____

1 AN ACT concerning

2 **Somerset County – Commissioners – Residency Requirements**

3 FOR the purpose of requiring each County Commissioner of Somerset County to reside in
4 a certain commissioners' district for a certain amount of time before *the filing*
5 *deadline for the* election as a Commissioner and during the term of office as
6 Commissioner; prohibiting a Commissioner from continuing to serve during the
7 current term of office if the Commissioner does not maintain a certain residency
8 under certain circumstances; authorizing an incumbent Commissioner who no
9 longer resides in a certain district due to a change in the district's boundaries to
10 continue as a Commissioner for the remainder of the term of office; and generally
11 relating to residency requirements for the County Commissioners of Somerset
12 County.

5 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
6 That the Laws of Maryland read as follows:

7 **Article 20 – Somerset County**

8 2–101.

9 (a) There are 5 County Commissioners for Somerset County, who hold office for 4
10 years and until their successors are elected and qualified.

11 **(B) (1) A COMMISSIONER ELECTED FROM A COMMISSIONERS’ DISTRICT**
12 **DESCRIBED IN § 2–102 OF THIS SUBTITLE MUST BE A RESIDENT OF THAT DISTRICT**
13 **DURING:**

14 **(I) THE 6 MONTHS IMMEDIATELY PRECEDING THE FILING**
15 **DEADLINE FOR THE ELECTION OF THE COMMISSIONER; AND**

16 **(II) THE FULL TERM OF OFFICE AS A COMMISSIONER.**

17 **(2) A COMMISSIONER FROM A COMMISSIONERS’ DISTRICT WHO DOES**
18 **NOT MAINTAIN RESIDENCY IN THAT DISTRICT MAY NOT CONTINUE AS A COUNTY**
19 **COMMISSIONER AND THE OFFICE SHALL BE DEEMED VACANT.**

20 **(3) IF THE BOUNDARY OF A COMMISSIONERS’ DISTRICT IS CHANGED,**
21 **THE TERM OF AN INCUMBENT COMMISSIONER WHO NO LONGER RESIDES IN THAT**
22 **DISTRICT BECAUSE OF THE CHANGE IS NOT AFFECTED DURING THAT TERM.**

23 **[(b)] (C) (1) Except as provided in paragraph (2) of this subsection, each**
24 **Commissioner shall receive an annual salary of \$8,500.**

25 **(2) The President of the County Commissioners shall receive an annual**
26 **salary of \$9,500.**

27 **[(c)] (D) Each Commissioner may receive reimbursement of no more than \$3,000**
28 **a year for expenses incurred for any official duties. The County Commissioner shall submit**
29 **a reimbursement voucher, signed by 3 of the 5 Commissioners.**

30 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
31 October 1, 2019.
