3 FOR the purpose of establishing that the Department of Natural Resources may plant or allow to be planted only certain native oyster shell of a certain species for use as 4 5 substrate for an oyster restoration, propagation, or replenishment project; 6 authorizing the Department to use certain alternate materials as substrate for a 7 project if certain entities recommend or approve the use and after the Department 8 prepares a certain analysis for and holds a public hearing on the project; providing 9 for the application of this Act; and generally relating to substrate material for oyster 10 planting.
