- FOR the purpose of providing that growers, processors, and dispensaries licensed under 4 certain provisions of law are subject to certain provisions of law; repealing the $\mathbf{5}$ 6 provision prohibiting the Natalie M. LaPrade Medical Cannabis Commission from 7 issuing more than one medical cannabis grower license to each applicant; prohibiting a person from having an ownership interest in or control of, including the power to 8 9 manage and operate, more than one grower; requiring the Natalie M. LaPrade 10 Medical Cannabis Commission to allow a person to have an ownership interest in or 11 control of up to a certain number of dispensaries licensed under a certain provision 12 of law; prohibiting a person from having an ownership interest in or control of, 13including the power to manage and operate, more than one processor; and generally relating to medical cannabis dispensaries. 14
