Higher Education - Tuition Rates - Exemptions

- FOR the purpose of altering the circumstances under which certain individuals are exempt from paying the out—of—state tuition rate at certain institutions of higher education; altering the circumstances under which certain individuals are eligible to pay a certain tuition rate at certain institutions of higher education; requiring certain individuals to retain a certain tuition status until the individual is awarded a certain degree under certain circumstances; making certain stylistic changes; and generally relating to tuition rates at public institutions of higher education.

- 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

- 1 (a) In this section, "individual":
- 2 (1) Includes an undocumented immigrant individual; and
- 3 (2) Does not include a nonimmigrant alien within the meaning of 8 U.S.C. 4 § 1101(a)(15).
 - (b) Notwithstanding any other provision of this article, an individual shall be exempt from paying the out—of—state tuition rate at [a community college] A PUBLIC INSTITUTION OF HIGHER EDUCATION in the State, AND SHALL BE ELIGIBLE FOR THE TUITION RATES DESCRIBED UNDER SUBSECTIONS (C) AND (D) OF THIS SECTION, if the individual:
- 10 (1) [Beginning with the 2005–2006 school year, attended] **ATTENDED** a public or nonpublic secondary school in the State [for at least 3 years];
- 12 (2) [Beginning with the 2007–2008 school year, graduated] **GRADUATED**13 from a public or nonpublic secondary school in the State or received the equivalent of a high school diploma in the State;
- 15 (3) Registers as an entering student in [a community college] A PUBLIC INSTITUTION OF HIGHER EDUCATION in the State [not earlier than the 2011 fall semester] NOT LATER THAN 6 YEARS AFTER GRADUATING FROM A PUBLIC OR NONPUBLIC SECONDARY SCHOOL IN THE STATE OR RECEIVING THE EQUIVALENT OF A HIGH SCHOOL DIPLOMA IN THE STATE:

- 6 (7) Registers in a community college in the State not later than 4 years 7 after graduating from a public or nonpublic secondary school in the State or receiving the 8 equivalent of a high school diploma in the State].

- 12 (1) Attended a community college not earlier than the 2010 fall semester 13 and met the requirements of subsection (b) of this section, except for the requirement set 14 forth in subsection (b)(3) of this section;
- 15 (2) Was awarded an associate's degree by or achieved 60 credits at a 16 community college in the State;
- 17 (3) Provides the public senior higher education institution a copy of the affidavit submitted under subsection (b)(5) of this section;
- 19 (4) Provides to the public senior higher education institution 20 documentation that the individual or the individual's parent or legal guardian has filed a 21 Maryland income tax return:
- 22 (i) Annually while the individual attended a community college in 23 the State:
- 24 (ii) Annually during the period, if any, between graduation from or 25 achieving 60 credits at a community college in the State and registration at a public senior 26 higher education institution in the State; and
