# Health – Professional and Volunteer Firefighter Innovative Cancer Screening Technologies Program

4 FOR the purpose of establishing the Professional and Volunteer Firefighter Innovative Cancer Screening Technologies Program; requiring the Maryland Department of  $\mathbf{5}$ 6 Health to administer the Program; authorizing the Department to adopt certain 7 regulations; providing for the purpose and goals of the Program; authorizing local 8 fire departments and volunteer fire companies and departments to apply to the 9 Department for certain grants; requiring a county in which a volunteer fire company 10 or department is located to assist volunteer companies or departments in filing certain applications; requiring the Department to issue a request for certain 11 12 applications for grants each year; specifying the contents of the application; 13 requiring the Department to develop a certain weighting formula; requiring the 14Department to prioritize awarding grants to certain applicants; requiring the 15Department to award the grants on a pro rata basis under certain circumstances; 16 requiring the Governor, for certain fiscal years, to include certain appropriations of 17money in the annual budget bill for the Program; providing that certain 18 appropriations and expenditures are subject to audit by the Office of Legislative 19 Audits: requiring the Department to report to certain committees of the General 20Assembly on or before a certain date each year; defining a certain term; and generally 21 relating to the Professional and Volunteer Firefighter Innovative Cancer Screening 22Technologies Program.

- 15 (4) THE TYPES OF CANCERS DETECTED BY THE TESTS.
