CHAPTER _____

1 AN ACT concerning

2 **Vehicle Laws – Electric Low Speed Scooters**

3 FOR the purpose of establishing that an electric low speed scooter is considered to be a
4 bicycle for the purposes of the Maryland Vehicle Law; defining the term “electric low
5 speed scooter”; providing that an electric low speed scooter is not considered to be a
6 motorized minibike, a motor scooter, or a motor vehicle for the purposes of the
7 Maryland Vehicle Law; altering the defined term “scooter” by limiting the term to
8 nonmotorized vehicles; establishing that the operator of an electric low speed scooter
9 may ride by standing on a platform designed to carry the operator; and generally
10 relating to electric low speed scooters.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

21 **Article – Transportation**

22 11–104.

23 “Bicycle” means:

24 (1) A vehicle that:

25 (i) Is designed to be operated by human power;

26 (ii) Has two or three wheels, of which one is more than 14 inches in
27 diameter; and

28 (iii) Has a drive mechanism other than by pedals directly attached to
29 a drive wheel;

30 (2) An electric bicycle; **[or]**

31 (3) A moped; **OR**

32 (4) **AN ELECTRIC LOW SPEED SCOOTER.**

1 11-117.2.

2 (A) "ELECTRIC LOW SPEED SCOOTER" MEANS A VEHICLE THAT:

3 (1) IS DESIGNED TO TRANSPORT ONLY THE OPERATOR;

4 (2) WEIGHS LESS THAN 100 POUNDS;

5 (3) HAS SINGLE WHEELS IN TANDEM OR A COMBINATION OF ONE OR
6 TWO WHEELS AT THE FRONT AND REAR OF THE VEHICLE;

7 (4) IS EQUIPPED WITH HANDLEBARS AND A PLATFORM DESIGNED TO
8 BE STOOD ON WHILE RIDING;

9 (5) IS SOLELY POWERED BY AN ELECTRIC MOTOR AND HUMAN
10 POWER; AND

11 (6) IS CAPABLE OF OPERATING AT A SPEED OF UP TO ~~25~~ 20 MILES PER
12 HOUR ~~ON A SMOOTH LEVEL SURFACE BY AN OPERATOR WEIGHING 175 POUNDS.~~

13 (B) "ELECTRIC LOW SPEED SCOOTER" DOES NOT INCLUDE:

14 (1) AN ELECTRIC PERSONAL ASSISTIVE MOBILITY DEVICE; OR

15 (2) AN ELECTRIC WHEELCHAIR OR OTHER MOBILITY AID USED BY A
16 DISABLED INDIVIDUAL.

18 (b) "Motorized minibike" does not include:

19 (1) A motor scooter;

20 (2) A moped;

21 (3) A farm tractor; [or]

22 (4) An electric bicycle; OR

23 (5) AN ELECTRIC LOW SPEED SCOOTER.

24 11-134.5.

25 (b) "Motor scooter" does not include [a]:

1 **(1) AN ELECTRIC LOW SPEED SCOOTER; OR**

2 **(2) A** vehicle that has been manufactured for off-road use, including a
3 motorcycle and an all-terrain vehicle.

5 (b) “Motor vehicle” does not include:

6 (1) A moped, as defined in § 11-134.1 of this subtitle;

7 (2) A motor scooter, as defined in § 11-134.5 of this subtitle; [or]

8 (3) An electric bicycle, as defined in § 11-117.1 of this subtitle; **OR**

9 **(4) AN ELECTRIC LOW SPEED SCOOTER, AS DEFINED IN § 11-117.2 OF**
10 **THIS SUBTITLE.**

11 11-154.1.

12 “Scooter” means a two-wheeled **NONMOTORIZED** vehicle that:

13 (1) Has handlebars; and

14 (2) Is designed to be stood on by the operator.

16 (a) Every person operating a bicycle or a motor scooter in a public bicycle area
17 has all the rights granted to and is subject to all the duties required of the driver of a vehicle
18 by this title, including the duties set forth in § 21-504 of this title, except:

19 (1) As otherwise provided in this subtitle; and

20 (2) For those provisions of this title that by their very nature cannot apply.

21 (b) (1) Subject to paragraphs (2) and (3) of this subsection, a person has the
22 rights and is subject to the restrictions applicable to pedestrians under this title while the
23 person is lawfully operating a bicycle, play vehicle, or unicycle:

24 (i) On a sidewalk or sidewalk area; or

25 (ii) In or through a crosswalk.

1 (2) At an intersection, a person operating a bicycle, play vehicle, or unicycle
2 is subject to all traffic control signals, as provided in §§ 21–202 and 21–203 of this title.

3 (3) Section 21–506 of this title does not apply to a person operating a
4 bicycle, play vehicle, or unicycle.

5 21–1203.

6 (a) The operator of a bicycle or a motor scooter may ride the bicycle or motor
7 scooter only [on]:

8 (1) ON or astride a permanent and regular seat securely attached to it; OR

9 (2) FOR AN ELECTRIC LOW SPEED SCOOTER, BY STANDING ON A
10 PLATFORM DESIGNED TO CARRY THE OPERATOR.

11 (b) A bicycle may not carry any passenger unless it is designed for and equipped
12 with a seat securely attached to it for each passenger.

13 (c) A motor scooter may not carry any passenger unless it is designed for and
14 equipped with a seat securely attached to it and footrests for each passenger.

15 25–102.

16 (a) The provisions of the Maryland Vehicle Law do not prevent a local authority,
17 in the reasonable exercise of its police power, from exercising the following powers as to
18 highways under its jurisdiction:

19 (8) Regulating the operation of bicycles, requiring them to be registered, and
20 imposing a registration fee;

21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
22 October 1, 2019.
