### CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Community Safety and Strengthening Act**

3 FOR the purpose of altering certain appropriations required to be made to a certain fund;  
4 requiring certain appropriations to be made to certain funds; providing that certain  
5 appropriations are in addition to certain other funding; establishing the Law  
6 Enforcement Apprenticeship Cadet Program in the Department of Labor, Licensing,  
7 and Regulation; specifying the purposes of the Cadet Program; requiring the  
8 Department of Labor, Licensing, and Regulation to administer the Cadet Program  
9 and award grants under the Cadet Program on a certain basis to certain law  
10 enforcement agencies; establishing the eligibility under the Cadet Program;  
11 requiring that the amount of a certain grant be based on the number of certain  
12 apprentices that are employed by the law enforcement agency; prohibiting the  
13 amount of a certain grant from exceeding a certain amount; requiring the Governor  
14 to include certain appropriations in the annual State budget for the Cadet Program;  
15 requiring the Department of Labor, Licensing, and Regulation to adopt certain

21 (a) (1) In this section the following words have the meanings indicated.

22 (2) “Anchor institution” means:

23 (i) an institution of higher education in the State; or

24 (ii) a hospital institution in the State that:

25 1. has a group of at least five physicians who are organized  
26 as a medical staff for the institution;

27 2. maintains facilities to provide, under the supervision of  
28 the medical staff, diagnostic and treatment services for two or more unrelated individuals;

30 3. admits or retains the individuals for overnight care.

31 (3) “Blighted area” means an area in which a majority of buildings have  
32 declined in productivity by reason of obsolescence, depreciation, or other causes to an extent  
33 that they no longer justify fundamental repairs and adequate maintenance.

1 (4) "Fund" means the Seed Community Development Anchor Institution  
2 Fund.

3 (b) There is a Seed Community Development Anchor Institution Fund.

4 (c) The purpose of the Fund is to provide grants and loans to anchor institutions  
5 for community development projects in blighted areas of the State.

6 (j) (1) For fiscal year 2019, the Governor shall include in the annual budget  
7 bill or the capital budget bill an appropriation of \$4,000,000 to the Fund.

8 (2) For fiscal [years] YEAR 2020 [through 2022], the Governor shall  
9 include in the annual budget bill or the capital budget bill an appropriation of \$5,000,000  
10 for the Fund.

11 (3) **FOR FISCAL YEAR 2021 AND EACH FISCAL YEAR THEREAFTER,**  
12 **THE GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL OR THE CAPITAL**  
13 **BUDGET BILL AN APPROPRIATION OF \$10,000,000 FOR THE FUND.**

14 PARTICULARLY YOUNG INDIVIDUALS, AND LAW ENFORCEMENT AGENCIES;

15 (3) DEVELOP A COHORT OF INDIVIDUALS QUALIFIED TO JOIN A LAW  
16 ENFORCEMENT AGENCY;

17 (4) ENCOURAGE LAW ENFORCEMENT AGENCIES TO HIRE  
18 APPRENTICES; AND

19 (5) HELP LAW ENFORCEMENT AGENCIES OFFSET ADDITIONAL COSTS,  
20 IF ANY, ASSOCIATED WITH HIRING APPRENTICES.

21 (D) (1) THE DEPARTMENT SHALL:

22 (I) ADMINISTER THE CADET PROGRAM; AND

23 (II) AWARD GRANTS UNDER THE CADET PROGRAM ON A  
24 COMPETITIVE BASIS TO LAW ENFORCEMENT AGENCIES THAT MEET THE  
25 REQUIREMENTS UNDER PARAGRAPH (2) OF THIS SUBSECTION.

26 (2) A LAW ENFORCEMENT AGENCY IS ELIGIBLE TO RECEIVE A GRANT  
27 IF THE LAW ENFORCEMENT AGENCY EMPLOYS AT LEAST ONE APPRENTICE WHO:

1                   **(I) HAS BEEN EMPLOYED BY THE AGENCY FOR AT LEAST 7**  
2 **MONTHS;**

3                   **(II) IS ENROLLED IN THE FIRST YEAR OF AN APPRENTICESHIP**  
4 **PROGRAM REGISTERED WITH THE MARYLAND APPRENTICESHIP AND TRAINING**  
5 **COUNCIL UNDER § 11-405(B) OF THIS TITLE; AND**

6                   **(III) LIVES IN A ZIP CODE IN WHICH AT LEAST 10% OF THE**  
7 **POPULATION IS BELOW THE POVERTY LEVEL AS ESTABLISHED BY THE U.S.**  
8 **DEPARTMENT OF COMMERCE, BUREAU OF THE CENSUS, IN THE MOST RECENTLY**  
9 **RELEASED DATA.**

10           **(E) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION,**  
11 **THE AMOUNT OF A GRANT AWARDED UNDER THE CADET PROGRAM:**

12                   **(I) SHALL BE BASED ON THE NUMBER OF APPRENTICES WHO**  
13 **MEET THE DESCRIPTION IN SUBSECTION (D)(2)(I) THROUGH (III) OF THIS SECTION**  
14 **WHO ARE EMPLOYED BY THE ELIGIBLE LAW ENFORCEMENT AGENCY; AND**

15                   **(II) MAY NOT EXCEED \$2,000 FOR EACH APPRENTICE WHO**  
16 **MEETS THE DESCRIPTION IN SUBSECTION (D)(2)(I) THROUGH (III) OF THIS SECTION**

20 **MEETS THE DESCRIPTION IN SUBSECTION (D)(2)(I) THROUGH (III) OF THIS SECTION**  
21 **WHO IS EMPLOYED BY THE ELIGIBLE UNIVERSITY LAW ENFORCEMENT AGENCY.**
