## Maryland Stadium Authority's Pimlico Race Course Study Workgroup

3 FOR the purpose of establishing the Workgroup to Study the Implementation of Phase 2 of 4 the Maryland Stadium Authority's Pimlico Race Course Study; providing for the 5 composition, chair, and staffing of the Workgroup; prohibiting a member of the 6 Workgroup from receiving certain compensation, but authorizing the reimbursement 7 of certain expenses; requiring the Workgroup to study and make recommendations 8 regarding certain matters; requiring the Workgroup to report its findings and 9 recommendations to the Governor and the General Assembly on or before a certain 10 date; requiring the Mayor and City Council of Baltimore City to report to the General 11 Assembly on or before a certain date; and generally relating to the Maryland 12 Stadium Authority financing construction of racetracks.

13 Preamble

WHEREAS, The redevelopment and revitalization of the Pimlico Race Course site would bring employment, health care, recreation, housing, and commercial opportunities to the site and the underinvested nearby neighborhoods; and

WHEREAS, As Phase 2 of the Pimlico Race Course Study concludes that a logical next step in the planning process is for key stakeholders, including the Maryland Jockey Club/The Stronach Group, the State of Maryland, and Baltimore City, to agree to execute a formal agreement to enter into future negotiations; now, therefore,

21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 22 That:

23 (a) There is a Workgroup to Study the Implementation of Phase 2 of the Maryland Stadium Authority's Pimlico Race Course Study.

- 1 The Workgroup consists of the following members: (b) 2 two representatives of the State of Maryland, appointed by the (1) 3 Governor; 4 (2)two representatives of Baltimore City, appointed by the Mayor of 5 Baltimore City; 6 two representatives of the Maryland Jockey Club, chosen by The (3)7 Stronach Group; and 8 **(4)** the Chair of the Maryland Stadium Authority, or the Chair's designee. 9 (c) The Chair of the Maryland Stadium Authority or the Chair's designee shall serve as the chair of the Workgroup. 10 11 (d) The Maryland Stadium Authority shall provide staff for the Workgroup. 12 A member of the Workgroup: (e) 13 (1) may not receive compensation as a member of the Workgroup; but 14 (2)is entitled to reimbursement for expenses under the Standard State 15 Travel Regulations, as provided in the State budget. 16 (f) The Workgroup shall: 17 (1) consult with the horsemen, breeders, and neighborhoods surrounding the Pimlico Race Course; 18 19 (2)assess the economic impact of the implementation of Phase 2 of the 20 Maryland Stadium Authority's Pimlico Race Course Study on Baltimore City, Baltimore 21County, the Baltimore region, and the State; 22 study the feasibility of various financing options for the implementation 23of Phase 2 of the Maryland Stadium Authority's Pimlico Race Course Study; and 24make recommendations regarding financing Phase 2 of the Maryland 25 Stadium Authority's Pimlico Race Course Study. 26 On or before December 1, 2019, the Workgroup shall report its findings and
