1 (f) (1) (i) On or before **THE FIRST MONDAY IN** August [31] in the year in 2 which a judge of the Court of Appeals must stand for continuance in office, the Clerk of the 3 Court of Appeals shall provide written notice to the State Board of the name of the judge 4 that is to be placed on the ballot at the next succeeding general election together with the 5 identification of the judicial circuit from which the qualified voters of that circuit may cast 6 a vote for the judge's continuance in office.

7 (ii) On or before **THE FIRST MONDAY IN** August [31] in the year in 8 which a judge of the Court of Special Appeals must stand for continuance in office, the Clerk 9 of the Court of Special Appeals shall provide written notice to the State Board of the name 10 of the judge that is to be placed on the ballot at the next succeeding general election together 11 with:

[(h) (1) On or before August 31 in the year in which a member of the Anne Arundel County Board of Education must stand for continuance in office, the Anne Arundel County Board of Education shall provide written notice to the State Board of the name of the member that is to be placed on the ballot at the next succeeding general election.

36 (a) A petition for the election of a charter board may not be filed unless all of the 37 signatures attached to the petition have been written by the signers within 6 months of the
