For over 90 years, the Hagerstown YMCA has been serving individuals and families in Hagerstown and Washington County through programs designed to help people and communities to learn, grow and thrive. The mission of the Hagerstown Y is to provide programs and service to all members of our community in the areas of youth development, healthy living and social responsibility. We are a cause-driven organization that believes a strong community can only be achieved when we invest in our children, our health and our neighbors. The Y does not to turn anyone away from our programs and services, regardless of their inability to pay. The Y provides a financial assistance program that allows participation in activities that promote health and well being a sliding scale to establish our fees.

11. Description and Purpose of Project (Limit length to visible area)

The Hagerstown Y would like to request support of bond bill funding for redesigning and replacing the HVAC system in the indoor pools. The units for the swimming pools are the single largest capacity pieces of HVAC equipment at the Y. The current rooftop units are original equipment from over eighteen years ago when the Y first opened its Eastern Boulevard location. In response to on-going maintenance issues and the inability to maintain consistent air flow, humidity and temperature, air flow and engineering studies were conducted over a period of nine months. These studies have concluded that replacement of the unit, along with some corrective design to the ducting, is the necessary solution moving forward. As with any aging equipment exposed to humidity and chlorine, it has reached the tipping point from repair to replace.

28. Comments

The Hagerstown Y currently has two indoor pools. One is a six-lane twenty-five-yard pool and the second is a smaller, warm water therapy and teaching pool. Both are programmed for use seven days per week. The pools serve a large cross section of the community and meet the needs of individuals and families across their lifespan. The replacement of the system is critical to the Y to continue to deliver on its mission to the community. The pool is a hub of activity every day and the demand on it is ever increasing. The pool is a vital function of the Y, as it is the one area of the facility that serves the population along the generational lifespan. From babies to seniors, the Y provides swimming instruction and therapy and exercise programs to a large segment of the population.

Swimming is a life skill as well as great exercise and a challenging sport. The Hagerstown Y offers swim lessons for all ages, family swim, arthritis and water therapy programs, competitive swimming teams, and many kinds of adaptive swim programs for kids with special needs, so we can all safely enjoy the pleasures of an aquatic environment. Teaching children how to be safe around water is not a luxury; it is a necessity. The Ys swim lesson program helps make sure they learn essential water safety skills, which can open a world of possibilities for them to satisfy their curiosity safely. The Y currently provides this program to the public as well as part of our summer camp and in-house Early Learning Center children as young as age two.

The current units, in addition to their age and deteriorated condition, lack sophisticated capacity controls of current technology and therefore consume more than 150% of the energy a newer system will require. In addition, the unit has deteriorated to the degree that there is no longer control correlation between the pool water temperature and the pool space temperature and humidity results in excessive operation and corresponding excessive cost.

No matter the age or physical condition of the participant, water is a great equalizer and can be safely enjoyed at all life stages with proper instruction and environment. Aquatics is one of our core services in helping to create a healthier community while at the same time addressing the safety challenges that pools and bodies of water present in or community. Since 1999 an average of 815 children under the age of 14 die as a result of unintentional drowning each year.
