# Task Force on the Premature Discharge of Patients With Substance Use Disorders

This bill establishes the Task Force on the Premature Discharge of Patients with Substance Use Disorders. The Maryland Department of Health (MDH) must provide staff for the task force. A member of the task force may not receive compensation but is entitled to reimbursement for expenses under the standard State travel regulations, as provided in the State budget. The task force must report its findings and recommendations to the Governor and the General Assembly by January 1, 2020. **The bill takes effect June 1, 2019, and terminates June 30, 2020.** 

## **Fiscal Summary**

**State Effect:** The bill's requirements can be handled with existing resources. Revenues are not affected.

**Local Effect:** Local health departments can participate with existing resources. Revenues are not affected.

**Small Business Effect:** None.

#### **Analysis**

**Bill Summary:** The task force must collect information on:

- the treatment practices for patients who are admitted to facilities designed to treat substance use disorders;
- the procedures for the discharge of patients from facilities designed to treat substance use disorders;

- the reasons patients assessed as needing inpatient treatment for the treatment of substance use disorders are discharged from treatment facilities; and
- patient abandonment practices at facilities designed to treat substance use disorders.

The task force must make recommendations regarding changes to improve staff training, patient treatment, and discharge practices at substance use treatment facilities, as well as whether such facilities should be required to report on the frequency of early patient discharge.

**Current Law/Background:** MDH's Behavioral Health Administration publishes several reports regarding behavioral health service utilization on its <u>website</u>, including:

- Average Length of Stay (Inpatient Care) Annual Reports: Includes average length of stay, discharges, and percentage of 30-day readmissions.
- Outcomes Measurement System (OMS): Interactive data search tool with survey information regarding number of youth and adults receiving mental health and/or substance use treatment per calendar or fiscal year. Includes survey results regarding living situation, psychiatric symptoms, substance use, level of function, school status, and other demographic information.

According to OMS, in fiscal 2018, there were 21,330 intakes of adults (ages 18 to 64) for substance-related disorders.

#### **Additional Information**

**Prior Introductions:** HB 1531 of 2018, a substantially similar bill, received a hearing in the House Health and Government Operations Committee but was withdrawn. Its cross file, SB 921, received a hearing in the Senate Finance Committee, but no further action was taken.
