AMENDMENTS TO HOUSE BILL 1313  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 16, after “assistance,” insert “providing for a delayed effective date.”.

AMENDMENT NO. 2

On page 3, in line 3, strike the colon; in line 4, strike “**1.**”; in the same line, after “**FAMILY**” insert “:

**1.**”;

in line 6, after “**OR**” insert “**A**”; in lines 6 and 7, strike “**REASONS THAT LEAD THE FAMILY TO:**” and substitute “**REASON; OR**

**2. LIVES IN:**”;

in lines 8 and 9, strike “**SHARE THE HOUSING OF OTHER PERSONS;**

**B. LIVE IN:**”;

in lines 9 and 10, strike “**CAR, PARK, PUBLIC SPACE, A VACANT BUILDING, SUBSTANDARD HOUSING, TRANSIT STATION,**” and substitute “**OR**”; in line 11, strike “**, OR SIMILAR SETTING; OR**” and substitute “**DUE TO A LACK OF ALTERNATIVE ACCOMMODATIONS;**”; in line 12, strike “**C.**” and substitute “**B.**”; in the same line, strike “**LIVE IN**”; in the same line, after “**EMERGENCY**” insert “**SHELTER**”; in the same line, strike “**SHELTER;**” and substitute “**HOUSING;**

C. A PRIMARY NIGHTTIME RESIDENCE THAT IS A PUBLIC OR PRIVATE PLACE NOT DESIGNED FOR OR ORDINARILY USED AS A REGULAR SLEEPING ACCOMMODATION FOR HUMAN BEINGS; OR

D. A CAR PARK, PUBLIC SPACE, VACANT OR ABANDONED BUILDING, SUBSTANDARD HOUSING, BUS STATION, TRAIN STATION, OR SIMILAR SETTING;

strike in their entirety lines 13 through 16, inclusive; in lines 21 and 22, strike “, **THE UNAVAILABILITY OF**”; in line 23, after “**1.**” insert “**THE UNAVAILABILITY OF**”; in line 25, after “**2.**” insert “**THE UNAVAILABILITY OR UNSUITABILITY OF**”; and in line 27, after “**3.**” insert “**THE UNAVAILABILITY OR UNSUITABILITY OF**”.

On page 8, in line 30, after “FIP” insert “**WORK ACTIVITY**”; and in line 34, after “**FIP**” insert “**WORK ACTIVITY**”.

On page 11, in line 3, strike “October 1, 2020” and substitute “July 1, 2021”.
