On page 3, in line 16, strike "HOLD MONTHLY MEETINGS" and substitute "ADOPT BYLAWS".

On pages 3 and 4, strike beginning with line 17 on page 3 through line 2 on page 4, inclusive, and substitute:

On page 5, in line 14, strike "4." and substitute "<u>3.</u>".
