AMENDMENT NO. 1

On page 1, in line 12, after the semicolon insert “requiring certain State agencies to maintain certain meeting minutes and recordings on their websites for a certain number of years after certain meetings.”.

AMENDMENT NO. 2

On page 3, in line 26, strike “AND”; and in line 29, strike the period and substitute “;AND”.

On page 4, in line 1, strike “(3)” and substitute “(III)”; in the same line, strike “THE CORPORATION SHALL MAKE PUBLICLY AVAILABLE”; after line 3, insert:

“(3) THE CORPORATION SHALL MAINTAIN ON ITS WEBSITE:

(I) MEETING MINUTES MADE AVAILABLE UNDER PARAGRAPH (2) OF THIS SUBSECTION FOR A MINIMUM OF 5 YEARS AFTER THE DATE OF THE MEETING; AND

On page 5, in line 16, strike “AND”; in line 19, strike the period and substitute “; AND”; in line 20, strike “(2)” and substitute “(III)”; in the same line, strike “THE STATE BOARD SHALL MAKE PUBLICLY AVAILABLE”; and after line 22, insert:

“(2) THE STATE BOARD SHALL MAINTAIN ON ITS WEBSITE:

(I) MEETING MINUTES MADE AVAILABLE UNDER PARAGRAPH (2) OF THIS SUBSECTION FOR A MINIMUM OF 5 YEARS AFTER THE DATE OF THE MEETING; AND

(I) MEETING MINUTES MADE AVAILABLE UNDER PARAGRAPH (2) OF THIS SUBSECTION FOR A MINIMUM OF 5 YEARS AFTER THE DATE OF THE MEETING; AND

(II) A COMPLETE AND UNEDITED ARCHIVED VIDEO RECORDING OF EACH OPEN MEETING FOR WHICH LIVE VIDEO STREAMING WAS MADE AVAILABLE UNDER PARAGRAPH (2) OF THIS SUBSECTION FOR A MINIMUM OF 1 YEAR AFTER THE DATE OF THE MEETING.”;
