AMENDMENTS TO HOUSE BILL 936

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “and Reilly” and substitute “Reilly, Bagnall, Bhandari, Carr, Charles, Chisholm, Cullison, Hill, Johnson, Kerr, Kipke, R. Lewis, Morgan, Pena–Melnyk, Pendergrass, Rosenberg, Saab, Sample–Hughes, Szeliga, and K. Young”; in line 2, after “Occupations –” insert “Advanced Practice Registered”; in the same line, strike “Nursing”; strike beginning with “an” in line 3 down through “or” in line 5; in line 6, after “nursing” insert “or other technical”; in line 7, strike “with medical training”; in the same line, after “circumstances;” insert “requiring the State Board of Nursing to adopt certain regulations;”; and in line 8, after “to” insert “advanced practice registered”.

AMENDMENT NO. 2

On page 2, in lines 17 and 19, in each instance, strike the bracket; in line 17, strike “, A”; in line 18, strike “, **OR AN ADVANCED PRACTICE REGISTERED NURSE**”; strike beginning with the colon in line 19 down through “AN” in line 20; in line 22, strike “; **OR**” and substitute a period; in line 23, strike “**(2)**” and substitute “**(D) (1)**”; in the same line, strike “**AN ASSISTANT WITH MEDICAL TRAINING**” and substitute “**SUBJECT TO REGULATIONS ADOPTED BY THE BOARD UNDER PARAGRAPH (2) OF THIS SUBSECTION, THIS SECTION DOES NOT PRECLUDE AN ADVANCED PRACTICE REGISTERED NURSE FROM DELEGATING A NURSING OR OTHER TECHNICAL TASK TO AN ASSISTANT**”; in line 25, strike “**AND ABLE**”; in line 26, after “**DELEGATING**” insert “**ADVANCED PRACTICE REGISTERED**”; and after line 30, insert:

“(2) THE BOARD SHALL ADOPT REGULATIONS TO CARRY OUT THIS SUBSECTION, INCLUDING REGULATIONS THAT:

(I) PROVIDE FOR THE MANNER IN WHICH AN ADVANCED PRACTICE REGISTERED NURSE DELEGATES A NURSING OR OTHER TECHNICAL TASK TO AN ASSISTANT;

(II) ESTABLISH LIMITATIONS ON THE AUTHORITY OF AN ADVANCED PRACTICE REGISTERED NURSE TO DELEGATE NURSING OR OTHER TECHNICAL TASKS TO AN ASSISTANT; AND

(III) OTHERWISE CLARIFY THE SCOPE OF THIS SUBSECTION.”.
