AMENDMENTS TO SENATE BILL 457  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, strike beginning with “legislative” in line 24 down through the first “government” in line 25 and substitute “local governing body”; in line 25, strike “devote” and substitute “dedicate”; in the same line, after the second “to” insert “the repayment of bonds for”; and in line 27, after “government” insert “and file jointly certain articles of incorporation and amendment”.

AMENDMENT NO. 2

On page 3, strike in their entirety lines 16 and 17; and in lines 18, 22, and 26, strike “(H)”, “(I)”, and “(J)”, respectively, and substitute “(G)”, “(H)”, and “(I)”, respectively.

On page 5, in line 5, strike “AUTHORITY” and substitute “BODY”; and in line 31, strike the comma and substitute “:

(I)”.

On page 6, in line 2, after “GOVERNMENT” insert “;AND

(II) ALL OBLIGATIONS OF THE RESILIENCE AUTHORITY SHALL BE TRANSFERRED TO AND ASSUMED BY THE INCORPORATING LOCAL GOVERNMENT”;

in line 9, after “ANY” insert “PERSONNEL”; in line 20, strike “MAY” and substitute “HAS AND MAY EXERCISE ALL POWERS NECESSARY OR CONVENIENT TO UNDERTAKE, FINANCE, MANAGE, ACQUIRE, OWN, CONVEY, OR SUPPORT RESILIENCE

**INFRASTRUCTURE PROJECTS, INCLUDING THE POWER TO**"; in line 27, strike "NONPROFIT" and substitute "**PRIVATE**"; and in line 30, before "CHARGE" insert "**SUBJECT TO THE APPROVAL OF THE LOCAL GOVERNING BODY,**".

On page 7, strike beginning with "PERFORM" in line 4 down through "PURPOSE" in line 5 and substitute "**ACT AS NECESSARY OR CONVENIENT TO CARRY OUT THE POWERS GRANTED TO IT BY LAW**"; and in line 16, strike "REVENUE BONDS" and substitute "**BONDS**".

On page 9, in line 1, strike "LEGISLATIVE BODY OF A LOCAL GOVERNMENT" and substitute "**LOCAL GOVERNING BODY**"; in line 6, strike the comma and substitute ":

**(1)**;

and in line 7, after "GOVERNMENT" insert "**;** **AND**

**(2) THE COUNTIES OR MUNICIPALITIES SHALL FILE JOINTLY ARTICLES OF INCORPORATION OR ARTICLES OF AMENDMENT IN ACCORDANCE WITH § 22-102 OF THIS SUBTITLE**".

On page 9, in line 1, strike "DEVOTE" and substitute "**DEDICATE**"; and in line 2, after "GOVERNMENT" insert "**FOR REPAYMENT OF BONDS AND**".
