AMENDMENTS TO SENATE BILL 927

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike “Issue Lobbying Communications – Lobbyist” and substitute “Lobbyists –”; strike beginning with “requiring” in line 4 down through “communications;” in line 6; strike beginning with “requiring” in line 16 down through “law;” in line 19; in line 24, strike “5–701, 5–702(a), and”; and in line 29, after “Section” insert “5–702(a) and”.

On page 2, in line 5, strike “and 5–718”.

AMENDMENT NO. 2

On pages 2 and 3, strike in their entirety the lines beginning with line 11 on page 2 through line 30 on page 3, inclusive.

On page 4, in lines 29 and 32, in each instance, strike the bracket; strike in their entirety lines 30 and 31; and in line 32, strike “(7)”.

On page 5, in line 23, after “(3)” insert “(I)”; in line 24, strike “§ 5–702(A)(6)” and substitute “§ 5–702(A)(5)”; in the same line, strike the colon and substitute “SUBMIT THE REPORTS REQUIRED UNDER THIS PARAGRAPH.”; in line 25, strike “(I)” and substitute “(II) 1. EXCEPT AS PROVIDED IN SUBSUBPARAGRAPH 2 OF THIS SUBPARAGRAPH, A REGULATED LOBBYIST SHALL”; in the same line, strike “NAME AND PERMANENT ADDRESS OF” and substitute “FOLLOWING INFORMATION FOR”; in lines 26 and 31, in each instance, strike “ENTITY” and substitute “PERSON”; strike beginning with the colon in line 26 down through “2.” in line 29; in line 30, strike “12” and substitute “6”; in the same line, after “MONTHS” insert “UNLESS THE DONOR EXPRESSLY STATES THAT THE DONATION MAY NOT BE USED FOR ANY OF THE”

ACTIVITIES REQUIRING REGISTRATION UNDER § 5-702(A) OF THIS SUBTITLE"; in the same line, strike "; AND" and substitute a colon; after line 30, insert:

"A. THE NAME AND PERMANENT ADDRESS OF THE DONOR;

B. THE AMOUNT OF THE DONATION; AND

C. THE DATE THE DONATION WAS RECEIVED BY THE REGULATED LOBBYIST.

2. THE FIRST REPORT FILED BY A REGULATED LOBBYIST UNDER THIS SUBSUBPARAGRAPH AFTER REGISTERING SHALL INCLUDE THE INFORMATION REQUIRED UNDER SUBSUBPARAGRAPH 1 OF THIS SUBPARAGRAPH FOR DONATIONS RECEIVED DURING THE PRECEDING 12 MONTHS.";

in line 31, strike "(II)" and substitute "(III) A REGULATED LOBBYIST SHALL,"; and in the same line, strike the first "AN" and substitute "A".

On page 6, in lines 3 and 5, in each instance, strike "ENTITY" and substitute "PERSON"; after line 16, insert:

"(3) "OFFICER" MEANS AN INDIVIDUAL WHO SERVES AS A BUSINESS ENTITY'S CHIEF EXECUTIVE OFFICER, PRESIDENT, VICE PRESIDENT, SECRETARY, TREASURER, CHIEF FINANCIAL OFFICER, MANAGING PARTNER, MANAGING MEMBER, OR PRINCIPAL, OR IN ANY OTHER FORMAL OR INFORMAL ROLE IN WHICH THE INDIVIDUAL EXERCISES SUBSTANTIAL INDEPENDENT RESPONSIBILITY FOR MANAGING THE AFFAIRS OF A BUSINESS ENTITY.";

and in line 17, strike “**(3)**” and substitute “**(4)**”.

On page 7, strike beginning with the comma in line 1 down through the second “**ACTION**” in line 3 and substitute “**UNDER § 5-702(A)(5) OF THIS SUBTITLE**”.

On page 8, in line 20, strike “**(1)**”; in lines 26 and 28, strike “**(I)**” and “**(II)**”, respectively, and substitute “**(1)**” and “**(2)**”, respectively; and strike in their entirety lines 30 and 31.

On pages 8 and 9, strike in their entirety the lines beginning with line 32 on page 8 through line 10 on page 9, inclusive.
