A BILL ENTITLED

1 AN ACT concerning

2 **Motor Vehicle Administration – Authority to Suspend Registration for**
3 **Violations Recorded by Traffic Control Signal Monitoring Systems – Repeal**

4 FOR the purpose of repealing the Motor Vehicle Administration’s authority to suspend the
5 registration of a motor vehicle if the owner or driver of the motor vehicle fails to pay
6 the penalty assessed for a certain violation recorded by a traffic control signal
7 monitoring system; and generally relating to the Motor Vehicle Administration and
8 traffic control signal monitoring systems.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

21 **Article – Transportation**

22 21–202.

23 (h) (1) Vehicular traffic facing a steady circular red signal alone:

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 (i) Shall stop at the near side of the intersection:

2 1. At a clearly marked stop line;

3 2. If there is no clearly marked stop line, before entering any
4 crosswalk; or

5 3. If there is no crosswalk, before entering the intersection;
6 and

7 (ii) Except as provided in subsections (i), (j), and (k) of this section,
8 shall remain stopped until a signal to proceed is shown.

9 (2) Vehicular traffic facing a steady red arrow signal:

10 (i) May not enter the intersection to make the movement indicated
11 by the arrow;

12 (ii) Unless entering the intersection to make a movement permitted
13 by another signal, shall stop at the near side of the intersection:

14 1. At a clearly marked stop line;

15 2. If there is no clearly marked stop line, before entering any
16 crosswalk; or

17 3. If there is no crosswalk, before entering the intersection;
18 and

19 (iii) Except as provided in subsections (i), (j), and (k) of this section,
20 shall remain stopped until a signal permitting the movement is shown.

21 21–202.1.

22 (a) (1) In this section the following words have the meanings indicated.

23 (5) “Traffic control signal monitoring system” means a device with one or
24 more motor vehicle sensors working in conjunction with a traffic control signal to produce
25 recorded images of motor vehicles entering an intersection against a red signal indication.

26 (c) This section applies to a violation of § 21–202(h) of this subtitle at an
27 intersection monitored by a traffic control signal monitoring system.

28 (d) (1) Unless the driver of the motor vehicle received a citation from a police
29 officer at the time of the violation, the owner or, in accordance with subsection (g)(5) of this
30 section, the driver of a motor vehicle is subject to a civil penalty if the motor vehicle is
31 recorded by a traffic control signal monitoring system while being operated in violation of

1 § 21–202(h) of this subtitle.

2 (2) A civil penalty under this subsection may not exceed \$100.

3 (h) If the civil penalty is not paid and the violation is not contested, the
4 Administration may refuse to register or reregister [or may suspend the registration of]
5 the motor vehicle.

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
7 October 1, 2020.
