A BILL ENTITLED

1 AN ACT concerning

2 **Anne Arundel County – Board of Education Budget – Equity Category**

3 FOR the purpose of requiring the Anne Arundel County Board of Education to include
4 certain additional categories in the Anne Arundel County Board of Education annual
5 budget; requiring the Anne Arundel County Board of Education to provide certain
6 information regarding the allocations for equity interventions in the Anne Arundel
7 County Board of Education budget; and generally relating to the Anne Arundel
8 County Board of Education budget.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

15 That the Laws of Maryland read as follows:

16 **Article – Education**

17 5–101.

18 **(G) (1) IN ADDITION TO ALL OTHER CATEGORIES REQUIRED BY**
19 **SUBSECTION (B) OF THIS SECTION, THE ANNE ARUNDEL COUNTY BOARD OF**
20 **EDUCATION ANNUAL BUDGET SHALL INCLUDE AN EQUITY CATEGORY.**

21 **(2) THE EQUITY CATEGORY SHALL INCLUDE FUNDING FOR EXISTING**
22 **AND PROPOSED EQUITY INTERVENTIONS IN THE ANNE ARUNDEL COUNTY PUBLIC**
23 **SCHOOL SYSTEM SEPARATED INTO THREE SUBCATEGORIES, INCLUDING:**

2 **EDUCATION FUNDING, DEDICATED TO IMPROVING THE OUTCOMES OF STUDENTS**
3 **WHO RECEIVE FREE AND REDUCED PRICE MEALS OR TO CLOSING THE OPPORTUNITY**
4 **GAPS ACROSS DEMOGRAPHICS, PARTICULARLY FOR HISTORICALLY UNDERSERVED**
5 **MINORITIES, THAT INCLUDES:**

6 1. **WRAPAROUND SERVICES;**

7 2. **ANTIBIAS TRAINING;**

8 3. **RESTORATIVE JUSTICE WORK;**

9 4. **DIFFERENTIATED STAFFING;**

10 5. **CONSULTING SERVICES FOR AN EQUITY ASSESSMENT;**

11 6. **FUNDING DEVOTED TO EQUITY LIAISONS IN THE**
12 **OFFICE OF EQUITY AND ACCELERATED STUDENT ACHIEVEMENT; AND**

15 **(II) A SUBCATEGORY FOR FEDERAL AND STATE ALLOCATIONS**
16 **PROVIDED TO THE ANNE ARUNDEL COUNTY BOARD OF EDUCATION FOR**
17 **INTERVENTIONS FOCUSED ON EQUITY, IN ADDITION TO GENERAL EDUCATION**
18 **FUNDING, THAT INCLUDES:**

19 1. **21ST CENTURY COMMUNITY LEARNING CENTERS**
20 **FUNDING;**

21 2. **MCKINNEY-VENTO HOMELESS ASSISTANCE ACT**
22 **FUNDING;**

23 3. **GRANTS PROVIDED UNDER §§ 5-217 AND 5-218 OF**
24 **THIS TITLE; AND**

25 4. **FEDERAL TITLE I AND TITLE III FUNDS; AND**

26 **(III) A SUBCATEGORY FOR GRANTS RECEIVED FROM PRIVATE**
27 **FOUNDATIONS THAT SUPPORT EQUITY INTERVENTIONS.**

28 **(3) FOR THE EQUITY CATEGORY SPECIFIED IN PARAGRAPH (1) OF**
29 **THIS SUBSECTION, THE ANNE ARUNDEL COUNTY BOARD OF EDUCATION SHALL**

1 PROVIDE INFORMATION ON WHETHER THE ALLOCATIONS FOR EQUITY
2 INTERVENTIONS IN THE ANNUAL BUDGET ARE BEING INCREASED, MAINTAINED, OR
3 REDUCED FROM THE PRIOR ANNUAL BUDGET FOR EACH SUBCATEGORY.

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
5 1, 2020.
