A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Transportation Authority – Video Streaming and Archiving – Open**
3 **Meetings**

4 FOR the purpose of requiring the Maryland Transportation Authority to make available to
5 the public on the Internet live video streaming and complete and unedited archived
6 video recordings of certain open meetings; requiring the Authority to make the
7 archived video recordings available for a certain minimum period of time; requiring
8 the Department of Information Technology to provide certain staff, support, and
9 equipment to the Authority; requiring the Authority to prepare written minutes of
10 open meetings; and generally relating to open meetings of the Authority.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Transportation**

19 **4–211.**

20 **(A) THE AUTHORITY SHALL MAKE AVAILABLE TO THE PUBLIC ON THE**
21 **INTERNET:**

22 **(1) LIVE VIDEO STREAMING OF EACH OPEN MEETING OF THE**
23 **AUTHORITY THAT IS HELD AT:**

1 **(I) THE HEADQUARTERS OF THE AUTHORITY; OR**

2 **(II) ANY OTHER LOCATION WHERE THE AUTHORITY HELD AT**
3 **LEAST 10 MEETINGS DURING THE IMMEDIATELY PRECEDING CALENDAR YEAR; AND**

4 **(2) A COMPLETE AND UNEDITED ARCHIVED VIDEO RECORDING OF**
5 **EACH OPEN MEETING FOR WHICH LIVE VIDEO STREAMING WAS MADE AVAILABLE**
6 **UNDER ITEM (1) OF THIS SUBSECTION FOR A MINIMUM OF 4 YEARS AFTER THE DATE**
7 **OF THE MEETING.**

8 **(B) THE DEPARTMENT OF INFORMATION TECHNOLOGY SHALL PROVIDE TO**
9 **THE AUTHORITY THE TECHNICAL STAFF, SUPPORT, AND EQUIPMENT NECESSARY TO**
10 **LIVESTREAM THE OPEN MEETINGS OF THE AUTHORITY.**

11 **(C) IN ADDITION TO SATISFYING THE REQUIREMENTS OF SUBSECTION (A)**
12 **OF THIS SECTION, THE AUTHORITY SHALL PREPARE WRITTEN MINUTES OF EACH**
13 **OPEN MEETING OF THE AUTHORITY.**

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
15 October 1, 2020.
