1 AN ACT concerning

Restorative Schools Fund and Grants - Establishment

3 FOR the purpose of establishing the Restorative Schools Fund as a special, nonlapsing 4 fund; specifying the purpose of the Fund; requiring the State Department of 5 Education to administer the Fund; requiring the State Treasurer to hold the Fund 6 and the Comptroller to account for the Fund; specifying the contents of the Fund; 7 specifying the purpose for which the Fund may be used; specifying the purpose for 8 which certain grants may be used; requiring the Department, under certain 9 circumstances, to develop processes and procedures for a local school system or an individual school to apply for a certain grant and for awarding the grant; providing 10 11 for the investment of money in and expenditures from the Fund; requiring interest 12 earnings of the Fund to be credited to the Fund; providing that a distribution from 13 the Fund is supplemental to and is not intended to take the place of certain funding; 14 exempting the Fund from a certain provision of law requiring interest earnings on 15 State money to accrue to the General Fund of the State; defining a certain term; and 16 generally relating to the Restorative Schools Fund and grants to develop and support 17 restorative approaches in local school systems and schools.
