## Public Schools - Provision of Menstrual Hygiene Products

3 FOR the purpose of requiring each county board of education to ensure that each public school provide, at no charge to students, menstrual hygiene products via dispensers 4 5 in the restrooms at the school; requiring a <u>public middle or high</u> school to install 6 menstrual hygiene product dispensers in a certain number of certain restrooms by 7 certain dates; requiring a public elementary school to install menstrual hygiene product dispensers in at least one restroom by a certain date; defining a certain term; 8 and generally relating to the provision of menstrual hygiene products in public 9 10 schools.
