13 14 15	A. Are in accordance with the manual and specifications for a uniform system of traffic control devices adopted by the State Highway Administration under $\S~25-104$ of this article; and
16	B. Indicate that a speed monitoring system is in use; and

With regard to a speed monitoring system placed on Maryland Route 210 (Indian Head Highway) in Prince George's County, ensure that each sign that indicates that a speed monitoring system is in use is proximate to a device that displays a real–time posting of the speed at which a driver is traveling.
