4 FOR the purpose of establishing the term of the president and vice president of the Anne
5 Arundel County Board of Education; providing that an individual who fills a certain
6 vacancy may be elected to serve as president or vice president; altering the date on
7 which the ~~Anne Arundel County Board of Education~~ county board is required to hold
8 its annual meeting; and generally relating to the annual meeting and officers of the
9 Anne Arundel County Board of Education.

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
4 That the Laws of Maryland read as follows:

5 **Article – Education**

6 **3-2A-06.1.**

7 **(A) THE PRESIDENT AND VICE PRESIDENT SHALL SERVE A TERM OF 1 YEAR.**

8 **(B) AN INDIVIDUAL WHO FILLS A VACANCY IN THE OFFICE OF AN ELECTED**
9 **MEMBER OF THE COUNTY BOARD UNDER § 3-2A-04 OF THIS SUBTITLE MAY BE**
10 **ELECTED TO SERVE AS PRESIDENT OR VICE PRESIDENT.**

11 4-107.

12 (a) Each county board shall hold an annual meeting on or as near as possible to
13 the second Tuesday in July, except that:

14 (1) In Allegany County, the annual meeting shall be held on the second
15 Tuesday in January;

16 **(2) IN ANNE ARUNDEL COUNTY, THE ANNUAL MEETING SHALL BE**
17 **HELD ON OR AS NEAR AS POSSIBLE TO THE FIRST WEDNESDAY IN DECEMBER;**

18 **[(2)] (3)** In Montgomery County, the annual meeting shall be held on or
19 before January 10;

20 **[(3)] (4)** In Prince George's County, the annual meeting shall be held on
21 the first Monday in December;

22 **[(4)] (5)** In St. Mary's County, the annual meeting shall be held following
23 the first Monday in December; and

24 **[(5)] (6)** In Washington County, the annual meeting shall be held in
25 December, on or before the 16th day.

26 (c) Except as provided in Title 3 of this article, each county board, at its annual
27 meeting, shall elect a president and a vice president from among its members by means of
28 an individually recorded vote.

29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
30 1, 2020.
