## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Frederick County – Career Exploration and Development Activities – Coffee**

3 FOR the purpose of ~~authorizing~~ prohibiting an Executive Branch agency ~~to ban or regulate~~  
4 from banning or regulating the sale of coffee in conjunction with a certain career  
5 exploration and development activity in a public high school in Frederick County;  
6 ~~providing a certain exception~~ repealing a certain exception that prohibited the sale  
7 of coffee in certain public high schools except under certain circumstances; and  
8 generally relating to the sale of coffee in conjunction with a career exploration and  
9 development activity in public high schools in Frederick County.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
16 That the Laws of Maryland read as follows:

17 **Article – Education**

18 7–423.1.

19 (a) This section applies only in Baltimore County AND **FREDERICK COUNTY**.

1 (b) ~~Except as provided in subsection (e) of this section, an~~ AN Executive Branch  
 2 agency may NOT ban or regulate the sale of coffee in conjunction with a career exploration  
 3 and development activity, IF THE ACTIVITY IS DIRECTED AT OR ORGANIZED BY  
 4 STUDENTS WITH INDIVIDUALIZED EDUCATION PROGRAMS, in a public high school.

5 ~~(e) An Executive Branch agency may not ban or regulate the sale of coffee in~~  
 6 ~~conjunction with a career exploration and development activity in a public high school that~~  
 7 ~~sold coffee on or before June 30, 2018.~~

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
 9 1, 2020.
