1 AN ACT concerning

Public Schools - Medical Cannabis - Guidelines for Administration to Students (Connor's Courage)

4 FOR the purpose of requiring, on or before a certain date, the State Department of $\mathbf{5}$ Education and the Natalie M. LaPrade Medical Cannabis Commission jointly to 6 develop guidelines for public schools regarding the administration of medical 7 cannabis to certain students during school hours and school-sponsored after-school 8 activities; providing for the contents of the guidelines; requiring, on or before a 9 certain date, the Department and the Commission jointly to provide certain technical assistance to schools for certain purposes and to develop a process to monitor 10 11 implementation of certain guidelines; and generally relating to medical cannabis and 12public schools.
