## 1 AN ACT concerning

## Occupational and Professional Licensing – Service Members, Veterans, and Military Spouses – Revisions to Reciprocity Requirements

4 FOR the purpose of altering the application requirements for a service member, veteran,  $\mathbf{5}$ or military spouse to apply for an occupational or professional license from a unit in 6 the Maryland Department of Labor to require submission of proof that the applicant 7 has held a certain license from another state for a certain period of time; requiring 8 that each license held by a certain applicant that was issued in another state be in 9 good standing; repealing a provision of law requiring a unit to make a certain determination regarding certain licensing requirements before issuing a certain 10 11 license; altering the authorization for a unit to circumstances under which a unit 12may issue a temporary license to a service member, veteran, or military spouse who 13 has held a certain license issued in another state for a certain period of time; and 14generally relating to occupational and professional licenses for service members, 15veterans, and military spouses.

1 [(c) Before issuing a license under this section, the unit shall determine that the 2 requirements for licensure in the other state are substantially equivalent to, or exceed the 3 requirements for, licensure in this State.]

5 (a) Subject to subsections (b) and (c) of this section, a unit may issue a temporary 6 license to a service member, veteran, or military spouse who [holds] HAS HELD a valid 7 license in good standing issued in another state [for which the requirements for licensure 8 are not substantially equivalent to the requirements for licensure in this State] FOR LESS 9 THAN 1 YEAR, PROVIDED THAT EACH VALID LICENSE HELD BY THE SERVICE 10 MEMBER, VETERAN, OR MILITARY SPOUSE IS IN GOOD STANDING.

11 (b) A temporary license issued under this section authorizes the service member, 12 veteran, or military spouse, for a limited period of time, as determined by the unit, to 13 perform services regulated by the unit while the service member, veteran, or military 14 spouse completes additional requirements for licensure in this State.

15 (c) A unit may not issue a license under this section if issuance of the license 16 would pose a risk to public health, welfare, or safety.

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 18 October 1, 2020.
