- 27 (E) AS PART OF THE LICENSE APPLICATION, A DEVELOPER SHALL INCLUDE:

- 1 OF THE CONTIGUOUS LICENSE HOLDERS WHOSE BEER, WINE, AND LIQUOR MAY BE
- 2 CONSUMED IN THE DESIGNATED OUTDOOR AREA; AND
- 3 (2) A SECURITY PLAN THAT HAS BEEN APPROVED BY THE 4 MONTGOMERY COUNTY POLICE DEPARTMENT.
- 5 (F) THE LICENSE HOLDER MAY ALLOW THE CONSUMPTION OF BEER, WINE, 6 AND LIQUOR IN THE DESIGNATED OUTDOOR AREA ON MONDAY THROUGH SUNDAY,
- 7 FROM 11 A.M. TO 11 P.M.
- 8 (G) THE ANNUAL LICENSE FEE IS \$4,000.
- 9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 10 1, 2020.
