State Lottery - Unclaimed Prizes - Distribution to Local Boards of Education

- 3 FOR the purpose of requiring the Director of the State Lottery and Gaming Control Agency,
- 4 at the end of each fiscal year, to remit money in the unclaimed State lottery prize
- 5 fund to the Comptroller for distribution to each county board of education in the
- 6 State in a certain manner; providing that a distribution from the fund is
- supplemental to and is not intended to take the place of certain funding; and
- 8 generally relating to the distribution of unclaimed State lottery prizes.
