18	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19	That the Laws of Maryland read as follows:

22	(a) (2) As to all or any part of any transportation facilities project, the

- 1 (i) Fix, revise, charge, and collect rentals, rates, fees, tolls, and other 2 charges and revenues for its use or for its services; and
- 3 (ii) Contract with any person who desires its use for any purpose and 4 fix the terms, conditions, rentals, rates, fees, tolls, or other charges or revenues for this use.
 - (b) The rentals, rates, fees, tolls, and other charges and revenues designated as security for any bonds issued under this subtitle shall be fixed and adjusted from time to time, either with respect to a particular transportation facilities project or in respect of the aggregate of the charges and revenues from other transportation facilities projects under the control of the Authority, as may be specified by law or in any applicable resolution or trust agreement, so as to provide funds that, together with any other available revenues, are sufficient as long as the bonds are outstanding and unpaid to:
- 12 (1) Pay the costs of maintaining, repairing, and operating the 13 transportation facilities project or projects financed in whole or in part by one or more series 14 of outstanding and unpaid bonds, to the extent that payment is not otherwise provided;
- 15 (2) Pay the principal of and the interest on these bonds as they become due 16 and payable;
- 17 (3) Create reasonable reserves that are anticipated will be needed for these 18 purposes; and
- 19 (4) Provide funds for paying the cost of replacements, renewals, and 20 improvements.
- 21 (c) (1) Except as otherwise provided in this subsection, the rentals, rates, fees, 22 tolls, and other charges and revenues are not subject to supervision or regulation by any 23 instrumentality, agency, or unit of this State or any of its political subdivisions.
- 24 (2) This subtitle does not permit the exercise of any power or the undertaking of any activity that would conflict with the provisions and limitations of the federal Urban Mass Transportation Act of 1964.
- 27 (3) Tolls for the use of the bridge carrying the John F. Kennedy Memorial 28 Highway over the Susquehanna River may not be less than the comparable tolls charged 29 for the use of the Susquehanna River Bridge.
- 30 (4) TOLLS FOR THE USE OF THE FRANCIS SCOTT KEY BRIDGE SHALL 31 BE SUBJECT TO THE FOLLOWING TOLL DISCOUNT PLAN OPTIONS:
- 32 (I) EXCEPT AS PROVIDED IN ITEM (II) OF THIS PARAGRAPH:
- 33 1. FOR A PASSENGER CAR, \$250 FOR A PERIOD OF 90 34 DAYS;

1	2. For a truck with two axles, \$350 for a period
2	OF 90 DAYS; AND
3	3. FOR A TRUCK WITH THREE AXLES, \$500 FOR A
4	PERIOD OF 90 DAYS; AND
5	(II) A \$20 ANNUAL FEE FOR A COMMUTER RESIDING IN ZIP
6	CODE 21060, 21061, 21062, 21122, 21144, 21219, 21220, 21221, 21222, 21224, OR
7	21226.
8	[(4)] (5) Prior to fixing or revising tolls on any part of any transportation
9	facilities project, the Authority shall provide, in accordance with § 2-1257 of the State
10	Government Article, to the Senate Budget and Taxation Committee, Senate Finance
11	Committee, House Appropriations Committee, and House Ways and Means Committee
12	information on the proposed toll charges, including:
13	(i) The annual revenues generated by the toll charges;
14	(ii) The proposed use of the revenues; and
15	(iii) The proposed commuter discount rates.
16 17	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2020.
