2 (e) If, whether by act of the parties or by operation of law, the title or ownership 3 interest in a vehicle assigned a special registration under this section is transferred from 4 the joint names of a husband and wife to the individual name of either spouse, the 5 transferee may continue to use the same special registration plates issued under this 6 section on the vehicle after the transfer.
