1 AN ACT concerning

Prescription Drug Monitoring Program – Out–of–State Pharmacists and Discipline for Noncompliance

4 FOR the purpose of altering the definition of the term "pharmacist" in provisions of law regarding the Prescription Drug Monitoring Program to include pharmacists $\mathbf{5}$ 6 licensed in other states to dispense monitored prescription drugs; altering the 7 grounds for which a certain health occupations board and certain disciplinary panels 8 are authorized to take disciplinary action against certain licensed dentists or 9 applicants for a license to practice dentistry, certain licensed physician assistants, 10 and certain licensed physicians for failing to comply with the requirements of the 11 Program; and generally relating to the Prescription Drug Monitoring Program.

6 (a) Subject to the hearing provisions of § 15–315 of this subtitle, a disciplinary 7 panel, on the affirmative vote of a majority of the quorum, may reprimand any physician 8 assistant, place any physician assistant on probation, or suspend or revoke a license if the 9 physician assistant:

12 (43) Fails to submit to a criminal history records check under § 14–308.1 of 13 this article; **OR**
