5 FOR the purpose of authorizing the County Council of Montgomery County to enact a local
6 law that grants to the Montgomery County Inspector General certain authority over
7 the Montgomery County Board of Education and public schools located in
8 Montgomery County; making conforming changes; and generally relating to the
9 authority of the County Council of Montgomery County and the Montgomery County
10 Inspector General.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **Article 16 – Montgomery County**

4 2–151A.

5 The County Council may, by local law, grant to the Inspector General the same
6 authority over [Montgomery College] **THE FOLLOWING ENTITIES** that the Inspector
7 General has over a department of County government:

8 **(1) THE HOUSING OPPORTUNITIES COMMISSION OF MONTGOMERY**
9 **COUNTY;**

10 **(2) MONTGOMERY COLLEGE; AND**

11 **(3) THE MONTGOMERY COUNTY BOARD OF EDUCATION AND THE**
12 **PUBLIC SCHOOLS LOCATED IN MONTGOMERY COUNTY.**

13 [2–151A.

14 The County Council may, by local law, grant to the Inspector General the same
15 authority over the Housing Opportunities Commission of Montgomery County that the
16 Inspector General has over a department of County government.]

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
18 October 1, 2020.
