1 AN ACT concerning

Divorce and Annulment - Removal of Barriers to Remarriage

3 FOR the purpose of requiring a party who files a complaint for an absolute divorce or 4 annulment to file an affidavit stating that the affiant has taken, or will take before 5 the entry of final judgment, all steps within the affiant's control to remove all 6 barriers to remarriage by the other party to the marriage or that the other party 7 waived in writing the submission of a certain affidavit; authorizing a party who files 8 a certain affidavit to request that the other party to the marriage file a certain 9 affidavit; prohibiting a court, under certain circumstances, from entering a final judgment of divorce or annulment; requiring a certain party to pay certain costs; 10 11 specifying that a person who knowingly submits a false affidavit is guilty of the crime 12 of perjury; defining a certain term; providing for the construction and application of 13 this Act; and generally relating to absolute divorce and annulment and the removal of barriers to remarriage. 14

- 20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 21 That the Laws of Maryland read as follows:
- 22 Article Family Law
- 23 **7–104.1.**
- 24 (A) IN THIS SECTION, "BARRIER TO REMARRIAGE" MEANS ANY 25 CONSCIENTIOUS RESTRAINT OR INHIBITION, SECULAR OR RELIGIOUS, AFFECTING

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



- 1 REMARRIAGE ACCORDING TO PRINCIPLES KNOWN BY THE PARTIES TO THE
- 2 MARRIAGE TO HAVE BEEN HELD BY THE PERSON WHO SOLEMNIZED THE MARRIAGE
- 3 OF THE PARTIES.
- 4 (B) THIS SECTION APPLIES ONLY TO A MARRIAGE SOLEMNIZED BY AN
- 5 OFFICIAL OF A RELIGIOUS ORDER OR BODY AUTHORIZED BY THE RULES AND
- 6 CUSTOMS OF THAT ORDER OR BODY TO PERFORM A MARRIAGE CEREMONY.
- 7 (C) (1) IN THIS SUBSECTION, "ALL STEPS" DOES NOT INCLUDE AN
- 8 APPLICATION TO A MARRIAGE TRIBUNAL OR OTHER SIMILAR ORGANIZATION OR
- 9 AGENCY OF A RELIGIOUS DENOMINATION THAT HAS AUTHORITY TO ANNUL OR
- 10 DISSOLVE A MARRIAGE UNDER THE RULES OF THE RELIGIOUS DENOMINATION.
- 11 (2) A PARTY WHO FILES A COMPLAINT FOR AN ABSOLUTE DIVORCE
- 12 OR ANNULMENT:
- 13 (I) SHALL FILE AN AFFIDAVIT STATING THAT:
- 14 THE AFFIANT HAS TAKEN, OR WILL TAKE BEFORE THE
- 15 ENTRY OF FINAL JUDGMENT, ALL STEPS WITHIN THE AFFIANT'S CONTROL TO
- 16 REMOVE ALL BARRIERS TO REMARRIAGE BY THE OTHER PARTY; OR
- 17 2. THE OTHER PARTY WAIVED, IN WRITING, THE
- 18 SUBMISSION OF AN AFFIDAVIT DESCRIBED IN ITEM 1 OF THIS ITEM; AND
- 19 (II) MAY REQUEST THAT THE OTHER PARTY TO THE MARRIAGE
- 20 FILE AN AFFIDAVIT STATING THAT THE OTHER PARTY HAS TAKEN, OR WILL TAKE
- 21 BEFORE THE ENTRY OF FINAL JUDGMENT, ALL STEPS WITHIN THE OTHER PARTY'S
- 21 BELOWE THE ENTIRE OF CAMERITY, THE STEELS WITHIN THE STREET
- 22 CONTROL TO REMOVE ALL BARRIERS TO REMARRIAGE BY THE PARTY WHO MADE
- 23 THE REQUEST.
- 24 (3) (I) If A PARTY MAKES A REQUEST UNDER PARAGRAPH (2)(II)
- 25 OF THIS SUBSECTION, A COURT MAY NOT ENTER A FINAL JUDGMENT OF DIVORCE OR
- 26 ANNULMENT UNLESS THE OTHER PARTY FILES AN AFFIDAVIT STATING THAT THE
- 27 OTHER PARTY HAS TAKEN, OR WILL TAKE BEFORE THE ENTRY OF FINAL JUDGMENT,
- 28 ALL STEPS WITHIN THE OTHER PARTY'S CONTROL TO REMOVE ALL BARRIERS TO
- 29 REMARRIAGE BY THE PARTY WHO MADE THE REQUEST.
- 30 (II) A COURT MAY NOT ENTER A FINAL JUDGMENT OF DIVORCE
- 31 OR ANNULMENT IF THE INDIVIDUAL WHO SOLEMNIZED THE MARRIAGE CERTIFIES,
- 32 IN AN AFFIDAVIT, THAT:
 - 1. THE INDIVIDUAL SOLEMNIZED THE MARRIAGE OF THE

1 PARTIES; AND

- 2. TO THE INDIVIDUAL'S KNOWLEDGE, A PARTY TO THE
- 3 MARRIAGE FAILED TO REMOVE A BARRIER TO REMARRIAGE OF THE OTHER PARTY.
- 4 (D) THE PARTY WHO REQUESTS THE REMOVAL OF BARRIERS TO
- 5 REMARRIAGE SHALL PAY THE REASONABLE COSTS, IF ANY, ASSOCIATED WITH THE
- 6 REMOVAL OF THE BARRIERS.
- 7 (E) THIS SECTION MAY NOT BE CONSTRUED TO AUTHORIZE A COURT TO:
- 8 (1) INQUIRE INTO OR DETERMINE ANY ECCLESIASTIC OR RELIGIOUS
- 9 ISSUE; OR
- 10 (2) ORDER A PARTY TO REMOVE A BARRIER TO REMARRIAGE.
- 11 (F) A PERSON WHO KNOWINGLY SUBMITS A FALSE AFFIDAVIT UNDER THIS
- 12 SECTION SHALL BE GUILTY OF PERJURY AND ON CONVICTION IS SUBJECT TO THE
- 13 PENALTY PROVIDED BY LAW.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall apply only to
- 15 cases pending or filed on or after the effective date of this Act.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect June
- 17 1, 2020.
