### 1 AN ACT concerning

# Home Energy Assistance - Critical Medical Needs Program - Power to the People Pilot Program

FOR the purpose of requiring the Office of Home Energy Programs, in coordination with 4  $\mathbf{5}$ the United Way of Central Maryland and the Fuel Fund of Maryland, to establish 6 the Power to the People Pilot Program on or before a certain date; stating the purpose 7 of the Pilot Program; requiring the Pilot Program to provide training for certain 8 individuals to serve as navigators under the Critical Medical Needs Program; 9 requiring the United Way of Central Maryland to develop a certain screening intake process; requiring certain intake specialists to perform certain duties; requiring the 10 11 Fuel Fund of Maryland to provide certain services; requiring the Governor to include 12a certain amount in the annual State budget for the Pilot Program; requiring that 13 certain funds be used in a certain manner; altering a certain definition; defining a 14 certain term; providing for the termination of this Act; and generally relating to the 15Power to the People Pilot Program.

# SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
