## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **State Retirement and Pension System – Pension Benefits – Calculation**

3 FOR the purpose of providing that, under certain retirement and pension systems, a  
4 member's normal service retirement allowance shall equal the member's annuity  
5 under certain circumstances; providing that, under certain pension systems, a  
6 former member's vested allowance shall equal the former member's annuity under  
7 certain circumstances; ~~altering a certain definition~~; providing for the application of  
8 this Act; and generally relating to the calculation of benefits in the State Retirement  
9 and Pension System.

9 (2) the Teachers’ Retirement System.

11 (a) A member may retire with a normal service retirement allowance if:

12 (1) on or before the date of retirement, the member:

13 (i) has at least 30 years of eligibility service; or

14 (ii) is at least 60 years old; and

15 (2) the member completes and submits a written application to the Board  
 16 of Trustees stating the date when the member desires to retire.

17 (b) **(1) [On] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**  
 18 **SUBSECTION, ON** retirement under this section, a member is entitled to receive a normal  
 19 service retirement allowance that equals one fifty-fifth of the member’s average final  
 20 compensation multiplied by the number of years of creditable service.

3 (a) Except as provided in subsection (f) of this section, a member may retire with

7 (2) on or before the date of retirement, the member:

8 (i) has at least 30 years of eligibility service;

9 (ii) has a combined total of at least 30 years of eligibility service from  
10 the Employees' Pension System, the Teachers' Pension System, the Employees' Retirement  
11 System, or the Teachers' Retirement System; or

12 (iii) has attained the age and the years of eligibility service as follows:

19 (b) Except as provided in subsections (c), (d), (e), [and] (f), AND (G) of this section,  
20 on retirement under this section, a member is entitled to receive a normal service  
21 retirement allowance that equals the number of years of the member's creditable service  
22 multiplied by:

23 (1) 0.8% of the member's average final compensation that is not in excess  
24 of the Social Security integration level; and

25 (2) 1.5% of the member's average final compensation that exceeds the  
26 Social Security integration level.

27 (c) Except as provided in [subsection (e)] SUBSECTIONS (E) AND (G) of this  
28 section, on retirement under this section, a member who is subject to the contributory  
29 pension benefit under Subtitle 2, Part II of this title is entitled to receive a normal service  
30 retirement allowance that equals the sum of:

31 (1) the number of years of the member's creditable service on or after July  
32 1, 1998 multiplied by 1.4% of the member's average final compensation; and

1 (2) the greater of:

2 (i) the number of years of the member's creditable service on or  
3 before June 30, 1998 multiplied by 1.2% of the member's average final compensation; or

4 (ii) the number of years of the member's creditable service on or  
5 before June 30, 1998 multiplied by:

6 1. 0.8% of the member's average final compensation that is  
7 not in excess of the Social Security integration level; and

8 2. 1.5% of the member's average final compensation that  
9 exceeds the Social Security integration level.

10 (d) Except as provided in [subsection (e)] **SUBSECTIONS (E) AND (G)** of this  
11 section, a member who is subject to the Alternate Contributory Pension Selection under  
12 Subtitle 2, Part III of this title is entitled to receive a normal service retirement allowance  
13 that equals the sum of:

14 (1) the greater of:

15 (i) the number of years of the member's creditable service on or  
16 before June 30, 1998 multiplied by 1.2% of the member's average final compensation; or

17 (ii) the number of years of the member's creditable service on or  
18 before June 30, 1998 multiplied by:

19 1. 0.8% of the member's average final compensation that is  
20 not in excess of the Social Security integration level; and

21 2. 1.5% of the member's average final compensation that  
22 exceeds the Social Security integration level; and

23 (2) the number of years of the member's creditable service on or after July  
24 1, 1998 multiplied by 1.8% of the member's average final compensation.

25 (e) (1) This subsection applies only to a member who has a combined total of  
26 30 years of eligibility service as provided in subsection (a)(2)(ii) of this section.

27 (2) A member is entitled to receive a normal service retirement allowance  
28 that equals:

29 (i) an allowance based on the creditable service the member earned  
30 in the Employees' Pension System;

31 (ii) an allowance based on the creditable service the member earned  
32 in the Employees' Retirement System;

1 (iii) an allowance based on the creditable service the member earned  
2 in the Teachers' Pension System; plus

3 (iv) an allowance based on the creditable service the member earned  
4 in the Teachers' Retirement System.

5 (f) (1) A member who begins membership on or after July 1, 2011, may retire  
6 with a normal service retirement allowance if:

7 (i) the member completes and submits a written application to the  
8 Board of Trustees stating the date when the member desires to retire; and

9 (ii) on or before the date of retirement, the member:

10 1. has at least 90 years of combined age and years of  
11 eligibility service; or

12 2. is at least 65 years old and has at least 10 years of  
13 eligibility service.

15 **member who is subject to the reformed contributory pension benefit under Subtitle 2, Part**

17 **years of the member's creditable service multiplied by 1.5% of the member's average final**  
18 **compensation.**

19 **(G) ON RETIREMENT UNDER THIS SECTION, IF A MEMBER'S ANNUITY IS**  
20 **GREATER THAN THE MEMBER'S NORMAL SERVICE RETIREMENT ALLOWANCE**  
21 **CALCULATED UNDER THIS SECTION, THE MEMBER'S NORMAL SERVICE RETIREMENT**  
22 **ALLOWANCE SHALL EQUAL THE MEMBER'S ANNUITY.**

24 This title applies to the State Police Retirement System.

25 24-401.

26 (a) (1) (i) This paragraph applies to an individual who is a member on or  
27 before June 30, 2011.

28 (ii) A member may retire with a normal service retirement allowance  
29 if:

30 1. on or before the date of retirement, the member:

31 A. has at least 22 years of eligibility service; or

1 B. is at least 50 years old; and

2 2. the member completes and submits a written application  
3 to the Board of Trustees, on the form that the Board of Trustees provides, stating the date  
4 when the member desires to retire.

5 (2) (i) This paragraph applies to an individual who becomes a member  
6 on or after July 1, 2011.

7 (ii) A member may retire with a normal service retirement allowance  
8 if:

9 1. on or before the date of retirement, the member:

10 A. has at least 25 years of eligibility service; or

11 B. is at least 50 years old; and

12 2. the member completes and submits a written application  
13 to the Board of Trustees, on the form that the Board of Trustees provides, stating the date  
14 when the member desires to retire.

15 (b) (1) Subject to the approval of the Board of Trustees, the Secretary of State  
16 Police may order a member who is at least 50 years old to retire on the first day of the  
17 month after the member is notified of the Secretary's order.

18 (2) Before approving the Secretary's order, the Board of Trustees shall give  
19 the member at least 30 days' notice and an opportunity to be heard.

20 (c) Except for the Secretary of State Police, a member shall retire with a normal  
21 service retirement allowance not later than the first day of the month after the member  
22 becomes 60 years old.

23 (d) (1) Except as provided in [paragraph (2)] **PARAGRAPHS (2) AND (3)** of  
24 this subsection, on retirement under this section, a member is entitled to receive a normal  
25 service retirement allowance that equals 2.55% of the member's average final compensation  
26 multiplied by each year of the member's years of creditable service.

27 (2) A member's normal service retirement allowance may not exceed 71.4%  
28 of the member's average final compensation.

29 **(3) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, ON**  
30 **RETIREMENT UNDER THIS SECTION, IF A MEMBER'S ANNUITY IS GREATER THAN THE**  
31 **MEMBER'S NORMAL SERVICE RETIREMENT ALLOWANCE CALCULATED UNDER**

1 PARAGRAPH (1) OF THIS SUBSECTION, THE MEMBER'S NORMAL SERVICE  
2 RETIREMENT ALLOWANCE SHALL EQUAL THE MEMBER'S ANNUITY.

3 (e) Subject to §§ 29–401, 29–402, and 29–403 of this article, a retiree, or a  
4 beneficiary of a retiree, who retires on or before June 30, 1999, with a service retirement  
5 allowance, shall receive an annual retirement allowance adjustment as of July 1, 1999, as  
6 follows:

7 (1) for a retiree who has been retired not more than 5 years, \$1,200;

8 (2) for a retiree who has been retired more than 5 years but not more than  
9 10 years, \$1,500;

10 (3) for a retiree who has been retired more than 10 years but not more than  
11 15 years, \$1,800; and

12 (4) for a retiree who has been retired more than 15 years, \$2,100.

14 This title applies to the Correctional Officers' Retirement System.

15 25–401.

16 (a) A member may retire with a normal service retirement allowance if:

17 (1) on or before the date of retirement, the member:

18 (i) has at least 20 years of eligibility service;

19 (ii) 1. is a correctional case management specialist, supervisor,  
20 or manager on or before June 30, 2016;

21 2. is vested in the Correctional Officers' Retirement System;  
22 and

23 3. has a combined total of at least 20 years of eligibility  
24 service from:

25 A. the Correctional Officers' Retirement System and the  
26 Employees' Retirement System; or

27 B. the Correctional Officers' Retirement System and the  
28 Employees' Pension System;

29 (iii) 1. is serving in a position specified in:

1 A. § 25–201(a)(8) or (9) of this title on or before June 30, 2017;  
2 or

3 B. § 25–201(a)(10) or (11) of this title on or before June 30,  
4 2018;

5 2. is vested in the Correctional Officers' Retirement System;  
6 and

7 3. has a combined total of at least 20 years of eligibility  
8 service from:

9 A. the Correctional Officers' Retirement System and the  
10 Employees' Retirement System; or

11 B. the Correctional Officers' Retirement System and the  
12 Employees' Pension System; or

13 (iv) is at least 55 years old and has:

14 1. at least 5 years of eligibility service credit, if the member  
15 is a member on or before June 30, 2011; or

16 2. at least 10 years of eligibility service credit, if the member  
17 becomes a member on or after July 1, 2011; and

18 (2) the member completes and submits a written application to the Board  
19 of Trustees stating the date when the member desires to retire.

8 This title applies to the Law Enforcement Officers' Pension System.

9 26–401.

10 (a) (1) Subject to paragraph (2) of this subsection, a member may retire with  
11 a normal service retirement allowance if:

12 (i) on or before the date of retirement, the member:

13 1. has at least 25 years of eligibility service; or

14 2. is at least 50 years old; and

15 (ii) the member completes and submits a written application to the  
16 Board of Trustees on the form that the Board of Trustees provides stating the date when  
17 the member desires to retire.

18 (2) A member may not retire before the first day of the month after  
19 employment ends.

20 (b) (1) Except as provided in [paragraphs (2) and (3)] **PARAGRAPHS (2), (3),**  
21 **AND (4)** of this subsection, on retirement under this section, a member is entitled to receive  
22 a normal service retirement allowance that equals the number of years of the member's  
23 creditable service multiplied by 2% of the member's average final compensation.

24 (2) A member's normal service retirement allowance under paragraph (1)  
25 of this subsection may not exceed 65% of the member's average final compensation.

26 (3) (i) This paragraph applies only to a member who is not subject to  
27 the Law Enforcement Officers' Modified Pension Benefit under Subtitle 2, Part II of this  
28 title.

29 (ii) **[On] EXCEPT AS PROVIDED IN PARAGRAPH (4) OF THIS**  
30 **SUBSECTION, ON** retirement under this paragraph, the member is entitled to receive a  
31 normal service retirement allowance that equals:

1 1. 2.3% of the member's average final compensation  
2 multiplied by each year of the member's first 30 years of creditable service; and

3 2. 1% of the member's average final compensation multiplied  
4 by each year of creditable service in excess of 30 years.

5 **(4) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, ON**  
6 **RETIREMENT UNDER THIS SECTION, IF A MEMBER'S ANNUITY IS GREATER THAN THE**  
7 **MEMBER'S NORMAL SERVICE RETIREMENT ALLOWANCE CALCULATED UNDER**  
8 **PARAGRAPH (1) OR (3) OF THIS SUBSECTION, THE MEMBER'S NORMAL SERVICE**  
9 **RETIREMENT ALLOWANCE SHALL EQUAL THE MEMBER'S ANNUITY.**

11 (a) This section applies only to members of:

12 (1) the Employees' Pension System;

13 (2) the Local Fire and Police System;

14 (3) the Law Enforcement Officers' Pension System; or

15 (4) the Teachers' Pension System.

16 (b) (1) This subsection applies to an individual who is a member on or before  
17 June 30, 2011.

18 (2) A member is eligible to receive a vested allowance if:

19 (i) the member separated from employment other than by death or  
20 retirement; and

21 (ii) the member has at least 5 years of eligibility service.

22 (b-1) (1) This subsection applies to an individual who becomes a member on or  
23 after July 1, 2011.

24 (2) A member is eligible to receive a vested allowance if:

25 (i) the member separated from employment other than by death or  
26 retirement; and

27 (ii) the member has at least 10 years of eligibility service.

28 (c) **(1)** Except as provided in subsections [(e), (f), and (g)] **(E) THROUGH (I)** of  
29 this section, a vested allowance:

1            [(1)] (I) is a deferred allowance that begins at normal retirement age;

2            [(2)] (II) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS  
3 SUBSECTION, is computed as a normal service retirement allowance on the basis of the  
4 member's average final compensation and eligibility service at separation from  
5 employment; and

6            [(3)] (III) may be paid in one of the optional forms of allowances under §  
7 21-403 of this article.

8            (2) ON RETIREMENT UNDER THIS SUBSECTION, IF A FORMER  
9 MEMBER'S ANNUITY IS GREATER THAN THE FORMER MEMBER'S NORMAL SERVICE  
10 RETIREMENT ALLOWANCE CALCULATED UNDER PARAGRAPH (1) OF THIS  
11 SUBSECTION, THE FORMER MEMBER'S NORMAL SERVICE RETIREMENT ALLOWANCE  
12 SHALL EQUAL THE FORMER MEMBER'S ANNUITY.

13            (d) If a member of the Employees' Pension System or the Teachers' Pension  
14 System separated from employment on or before June 30, 1990, unused sick leave reported  
15 by the member's employer at the time of separation from employment is creditable service  
16 for computing the vested allowance.

17            (e) Except as provided in subsection (f) of this section, a former member of the  
18 Employees' Pension System or the Teachers' Pension System who has separated from  
19 employment before the age of 55 with at least 15 years of eligibility service is eligible to  
20 receive a vested allowance that:

21            (1) begins on the first day of the month following the member's 55th  
22 birthday; and

23            (2) equals the reduced allowance computed under § 23-402 of this article.

24            (f) (1) The vested allowance of a former member of the Employees' Pension  
25 System or the Teachers' Pension System who separates from employment on or before June  
26 30, 1998:

27            (i) is a deferred allowance that begins at normal retirement age;

28 AND

29            (ii) EXCEPT AS PROVIDED IN PARAGRAPH (2)(II) OF THIS  
30 SUBSECTION, is computed on the basis of the member's average final compensation and  
31 eligibility service at separation from employment[;].

32            [(iii)] (2) (I) EXCEPT AS PROVIDED IN SUBPARAGRAPH (II)  
33 OF THIS PARAGRAPH, THE VESTED ALLOWANCE DESCRIBED UNDER PARAGRAPH (1)

1 **OF THIS SUBSECTION** shall equal the number of years of the member's creditable service  
2 multiplied by:

3 1. 0.8% of the member's average final compensation that is  
4 not in excess of the Social Security integration level; and

5 2. 1.5% of the member's average final compensation that  
6 exceeds the Social Security integration level[; and].

7 **[(iv)] (ii) IF THE FORMER MEMBER'S ANNUITY IS GREATER**  
8 **THAN THE FORMER MEMBER'S VESTED ALLOWANCE CALCULATED UNDER**  
9 **SUBPARAGRAPH (I) OF THIS PARAGRAPH, THE FORMER MEMBER'S VESTED**  
10 **ALLOWANCE SHALL EQUAL THE FORMER MEMBER'S ANNUITY.**

11 **(iii) THE FORMER MEMBER'S VESTED ALLOWANCE** may be paid in  
12 one of the optional forms of allowances under § 21-403 of this article.

13 **[(2)] (3)** A former member of the Employees' Pension System or the  
14 Teachers' Pension System who has separated from employment on or before June 30, 1998  
15 and before the age of 55 with at least 15 years of eligibility service is eligible to receive a  
16 vested allowance that:

17 (i) begins on the first day of the month following the member's 55th  
18 birthday; and

19 (ii) equals the allowance under paragraph **[(1)] (2)** of this  
20 subsection, reduced by 0.5% for each month that the member's early retirement date  
21 precedes the date the member will be 62 years old.

22 (g) (1) Except as provided in [paragraph (2) of this] subsection **(H) OF THIS**  
23 **SECTION** and subject to [paragraph (3) of this] subsection **(I) OF THIS SECTION**, the vested  
24 allowance of a former member of the Law Enforcement Officers' Pension System who  
25 separates from employment on or before June 30, 2000:

26 (i) is a deferred allowance that begins at normal retirement age;  
27 **AND**

28 (ii) **EXCEPT AS PROVIDED IN PARAGRAPH (2)(II) OF THIS**  
29 **SUBSECTION**, is computed on the basis of the member's average final compensation and  
30 eligibility service at separation from employment[; and].

31 **[(iii)] (2) (I) EXCEPT AS PROVIDED IN SUBPARAGRAPH (II)**  
32 **OF THIS PARAGRAPH, THE VESTED ALLOWANCE DESCRIBED UNDER PARAGRAPH (1)**  
33 **OF THIS SUBSECTION** shall equal the number of years of the member's creditable service  
34 multiplied by:

1                   1.     1% of the member's average final compensation that is not  
2 in excess of the Social Security integration level; and

3                   2.     1.7% of the member's average final compensation that  
4 exceeds the Social Security integration level.

5                   **(II) IF THE FORMER MEMBER'S ANNUITY IS GREATER THAN THE**  
6 **FORMER MEMBER'S VESTED ALLOWANCE CALCULATED UNDER SUBPARAGRAPH (I)**  
7 **OF THIS PARAGRAPH, THE FORMER MEMBER'S VESTED ALLOWANCE SHALL EQUAL**  
8 **THE FORMER MEMBER'S ANNUITY.**

9                   **[(2) (i) (H) (1)]** This [paragraph] **SUBSECTION** applies only to a former  
10 member of the Law Enforcement Officers' Pension System who:

11                   **[1.] (I)** transferred to the Law Enforcement Officers'  
12 Pension System from the Employees' Retirement System; and

13                   **[2.] (II)** separates from employment on or before June 30,  
14 2000.

15                   **[(ii) (2)]** The vested allowance of a former member:

16                   **[1.] (I)** is a deferred allowance that begins at normal  
17 retirement age; AND

18                   **[2.] (II) EXCEPT AS PROVIDED IN PARAGRAPH (4) OF**  
19 **THIS SUBSECTION, is computed on the basis of the member's average final compensation**  
20 **and eligibility service at separation from employment[; and].**

21                   **[3.] (3) EXCEPT AS PROVIDED IN PARAGRAPH (4) OF**  
22 **THIS SUBSECTION, THE VESTED ALLOWANCE DESCRIBED UNDER PARAGRAPH (2) OF**  
23 **THIS SUBSECTION shall equal:**

24                   **[A.] (I)** 2% of the member's average final compensation  
25 multiplied by each year of the member's first 30 years of creditable service; and

26                   **[B.] (II)** 1% of the member's average final compensation  
27 multiplied by each year of creditable service in excess of 30 years.

28                   **(4) IF THE FORMER MEMBER'S ANNUITY IS GREATER THAN THE**  
29 **FORMER MEMBER'S VESTED ALLOWANCE CALCULATED UNDER PARAGRAPH (3) OF**  
30 **THIS SUBSECTION, THE FORMER MEMBER'S VESTED ALLOWANCE SHALL EQUAL THE**  
31 **FORMER MEMBER'S ANNUITY.**

1            **[(3) (i) (I) (1)]** This paragraph applies only to a former member who is:

2                            **[1.] (I)** receiving a deferred allowance under **[paragraph (1)**  
3 **of this] subsection (G) OF THIS SECTION;** and

4                            **[2.] (II)** under the age of 62 years.

5                            **[(ii) (2)]** On receipt of a vested allowance, a former member shall  
6 receive a supplemental deferred allowance that equals the difference between:

7                            **[1.] (I)** the former member's vested allowance; and

8                            **[2.] (II)** 1.7% of the member's average final compensation  
9 for each year of creditable service.

10                           **[(iii) (3)]** Payment of the supplemental deferred allowance ends  
11 when the former member:

12                           **[1.] (I)** attains the age of 62 years; or

13                           **[2.] (II)** dies.

14            **[(h) (J) (1)]** If a former member who elected a vested allowance requests the  
15 return of accumulated contributions before payment of the vested allowance begins, the  
16 Board of Trustees shall return the accumulated contributions to the former member.

17                           **(2)** When accumulated contributions are returned to a former member, the  
18 former member is not entitled to further benefits on account of the former member's  
19 previous membership.

20            **SECTION 2. AND BE IT FURTHER ENACTED,** That this Act shall be construed to  
21 apply retroactively and shall be applied to and interpreted to affect any individual who on  
22 or after October 1, 2013, had a retirement account created or adjusted in one of the following  
23 systems of the State Retirement and Pension System:

24                           **(1)** the Employees' Retirement System;

25                           **(2)** the Employees' Pension System;

26                           **(3)** the Teachers' Retirement System; or

27                           **(4)** the Teachers' Pension System.

28            **SECTION 3. AND BE IT FURTHER ENACTED,** That this Act shall take effect July  
29 1, 2020.
