A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Higher Education Outreach and College Access Pilot Program –**
3 **Alterations**
4 **(Maryland College Access Act)**

5 FOR the purpose of repealing the termination date of the Maryland Higher Education
6 Outreach and College Access Pilot Program; altering the title of the Program;
7 requiring the Governor to include in the annual budget bill a certain appropriation
8 for the Program; altering the dates of a certain report on the Program; altering a
9 certain definition; making conforming changes; and generally relating to the
10 Maryland Higher Education Outreach and College Access Pilot Program.

9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
10 That the Laws of Maryland read as follows:

11 **Article – Education**

12 Subtitle 11. Maryland Higher Education Outreach and College Access [Pilot] Program.

13 11–1101.

14 (a) In this subtitle the following words have the meanings indicated.

15 (b) “Nonprofit organization” means an organization that is exempt or eligible for
16 exemption from taxation under § 501(c)(3) of the Internal Revenue Code.

17 (c) “Program” means the Maryland Higher Education Outreach and College
18 Access [Pilot] Program.

19 11–1102.

20 There is a Maryland Higher Education Outreach and College Access [Pilot] Program.

21 11–1103.

22 The purposes of the Program are to:

23 (1) Encourage low–income Maryland high school students to attend and
24 complete college;

25 (2) Connect potential college and university students with nonprofit
26 organizations that have a history of successful higher education outcomes for targeted
27 youth;

28 (3) Create an equal matching fund for nonprofit organizations to access in
29 order to increase college outreach services to low–income students;

30 (4) Provide funding for nonprofit organizations that are already
31 established in communities to provide targeted outreach to encourage low–income students

1 to enroll in college; and

2 (5) [Establish a 5-year pilot program to determine if the Program can lead
3 to an increase in] **INCREASE THE NUMBER OF** low-income students attending and
4 succeeding in college.

5 11-1104.

6 (a) The Commission shall administer the Program.

7 (b) To carry out the purposes of the Program, the Commission shall:

8 (1) Establish a grant program to be published on the Commission's website
9 through which nonprofit organizations may learn about eligibility, application, and
10 compliance requirements and apply for funding as provided under this subtitle;

11 (2) Develop application requirements and review and approve applications;

12 (3) Develop a process for verifying that matching funds are available; and

13 (4) Allocate funding to approved nonprofit organizations on a competitive
14 basis.

15 11-1105.

16 (a) To be eligible for participation in the Program, a nonprofit organization shall:

17 (1) Be located in the State;

18 (2) Have a contract or memorandum of understanding with a local school
19 system or an institution of higher education or must establish one if one does not exist; and

20 (3) Demonstrate an equal match for funds requested.

21 (b) A nonprofit organization that receives funding through the Program shall:

22 (1) Submit data on outreach programs;

23 (2) Track student progress through the higher education system; and

24 (3) Submit annual reports to the Commission on or before October 1
25 following the fiscal year in which funds were received.

26 11-1106.

27 (a) The Commission shall prepare a report on the Program that includes:

1 (1) A summary of the reports received from the participating nonprofit
2 organizations regarding the Program;

3 (2) The amount of funds distributed each fiscal year;

4 (3) Information regarding the effectiveness of the Program, including
5 whether students matriculate and remain continuously enrolled in higher education as a
6 result of the Program; and

7 (4) If an eligible wait list exists, the number of nonprofit organizations on
8 the wait list.

9 (b) On or before December 1 [in 2017 through 2021] **EACH YEAR**, the Commission
10 shall submit a copy of the report required under subsection (a) of this section to the General
11 Assembly, in accordance with § 2-1257 of the State Government Article.

12 **11-1107.**

13 **FOR FISCAL YEAR 2022 AND EACH FISCAL YEAR THEREAFTER, THE**
14 **GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION OF**
15 **\$200,000 FOR THE PROGRAM.**

18 October 1, 2015. [It shall remain effective for a period of 7 years and, at the end of

25 shall be abrogated and of no further force and effect.]

27 1, 2020.
