Vehicle Laws - Liens - Electronic Recording

3 FOR the purpose of requiring certain persons to record certain information related to motor 4 vehicle liens with the Motor Vehicle Administration electronically within a certain 5 period of time; requiring, rather than authorizing, the Administration to develop and 6 implement an electronic system for recording and releasing security interests; 7 authorizing the Administration to make certain information available electronically; 8 authorizing certain parties to submit electronic lien information to the 9 Administration on behalf of certain other parties; authorizing the Administration to adopt regulations to facilitate electronic reporting of motor vehicle liens; making 10 11 certain conforming changes; providing for a delayed effective date; and generally 12 relating to the electronic recording of motor vehicle liens.

- 1 (a) (1) After the buyer has paid all sums due under an agreement, the holder shall deliver or mail to the buyer at his last known address, within 15 days after the holder receives a written request from the buyer:
- 4 **[**(1)**] (I)** A signed statement which describes the goods and states that all payments due or to become due under the agreement are paid in full;
- 6 **[(2)] (II)** Good and sufficient instruments to release all security interests 7 in the goods and collateral security owned by the buyer; and
- 8 **[**(3)**] (III)** Good and sufficient assignments and instruments necessary to 9 vest the buyer with complete evidence of title.
- 10 (2) If the release required by this subsection pertains to a Motor vehicle, the release shall be filed electronically with the Motor Vehicle Administration within 3 business days in accordance with § 13–108.1 of the Transportation Article.
- 14 (b) After the buyer has paid all sums due under an agreement, the holder shall 15 deliver or mail to each surety for the buyer and to each person who is the owner of collateral 16 security, within 15 days after the holder receives a request from the buyer, surety, or other 17 person:
- 18 (1) A signed statement which shows that the suretyship is completely 19 discharged; and
- 20 (2) Good and sufficient instruments to release any collateral security 21 owned by that person.
- 22 (c) If the holder fails to comply with the requirements of this section, he shall 23 forfeit \$10 to the buyer and is liable for damages.

- 25 (a) (1) Except as provided in paragraph (2) of this subsection, this section 26 applies only to a loan made by a credit grantor to a consumer borrower.
- 27 (2) This section does not apply to a loan to which \S 3–105.1 of the Real Property Article applies.
- 29 (b) Within a reasonable time after a loan to a consumer borrower has been repaid 30 in full and all other obligations under the agreement, note, or other evidence of the loan 31 have been fulfilled, a credit grantor shall:
- 32 (1) (i) Indelibly mark with the word "paid" or "canceled" and return to

- 1 the consumer borrower each agreement, note, or other evidence of the loan; or 2 Furnish the consumer borrower with a written statement that (ii) 3 identifies the loan transaction and states that the loan has been paid in full; and 4 Release any recorded mortgage, deed of trust, security agreement, or (2)5 other lien securing the loan. 6 (c) **(1)** The release shall be: 7 [(1)] (I) In writing; and 8 [(2)] (II) Prepared at the expense of the credit grantor. 9 **(2)** IF THE RELEASE REQUIRED BY THIS SECTION PERTAINS TO A 10 MOTOR VEHICLE, THE RELEASE SHALL BE FILED ELECTRONICALLY WITH THE 11 MOTOR VEHICLE ADMINISTRATION WITHIN 3 BUSINESS DAYS IN ACCORDANCE 12 WITH § 13–108.1 OF THE TRANSPORTATION ARTICLE. 13 (1) If the credit grantor does not record the release, the credit grantor shall furnish the consumer borrower with the release in a recordable form. 14 15 (2)If the credit grantor records the release, the credit grantor shall furnish the consumer borrower with a copy of the release. 16 17 (e) (1) If a fee is collected by a credit grantor for the recording of a release: 18 (i) The release shall be recorded by the credit grantor; and 19 Any portion of the fee not paid to a governmental entity for 20 recording the release shall be refunded to the borrower. 21If a fee is not collected by a credit grantor for the recording of a release, 22the credit grantor is not obligated to record the release. 23 **Article - Transportation** 2413-108.1. 25Notwithstanding any other provision of this title, the Administration may 26 develop and implement an electronic system for the issuance of certificates of title and 27 SHALL DEVELOP AND IMPLEMENT AN ELECTRONIC SYSTEM FOR the recording and 28releasing of security interests.
