AN ACT concerning

## Alcoholic Beverages - Class MD License

FOR the purpose of establishing a Class MD beer, wine, and liquor license for a certain purpose in certain jurisdictions; authorizing a license holder to sell beer, wine, and liquor manufactured in the State for on-premises consumption in accordance with certain requirements; prohibiting a Class MD beer, wine, and liquor license from being subject to, or included in, certain license quotas; specifying the hours and days of sale in certain jurisdictions; specifying an annual license fee; and generally relating to alcoholic beverages licenses in the State.
