## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Capital Funding – Deferred Maintenance – Reporting Requirements**

3 FOR the purpose of requiring certain entities that receive in a prior fiscal year a certain  
4 amount of State capital funding for certain facilities to submit a report on deferred  
5 maintenance; requiring certain entities to report to certain committees of the  
6 General Assembly on or before a certain date; requiring the report to include certain  
7 information; defining certain terms; and generally relating to a report on deferred  
8 maintenance.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

15 That the Laws of Maryland read as follows:

16 **Article – State Finance and Procurement**

17 **8–304.**

18 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS  
19 INDICATED.

1           **(2) “CONVENTION FACILITY” HAS THE MEANING STATED IN § 10–601**  
2 **OF THE ECONOMIC DEVELOPMENT ARTICLE.**

3           **(3) “INSTITUTION OF HIGHER EDUCATION” HAS THE MEANING**  
4 **STATED IN § 10–101 OF THE EDUCATION ARTICLE.**

5           **(B) THIS SECTION APPLIES TO A CONVENTION FACILITY AND A FACILITY AT**  
6 **AN INSTITUTION OF HIGHER EDUCATION THAT RECEIVES STATE CAPITAL FUNDING**  
7 **TOTALING AT LEAST \$2,000,000 IN THE OPERATING OR CAPITAL BUDGET BILLS IN**  
8 **THE PRIOR FISCAL YEAR.**

9           **(C) SUBJECT TO SUBSECTION (D) OF THIS SECTION, ON OR BEFORE**  
10 **OCTOBER 1 EACH YEAR, THE ENTITY RESPONSIBLE FOR FACILITIES MAINTENANCE**  
11 **FOR A FACILITY SPECIFIED IN SUBSECTION (B) OF THIS SECTION SHALL SUBMIT A**  
12 **REPORT IN ACCORDANCE WITH § 2–1257 OF THE STATE GOVERNMENT ARTICLE TO**  
13 **THE SENATE BUDGET AND TAXATION COMMITTEE AND THE HOUSE**  
14 **APPROPRIATIONS COMMITTEE ON THE ENTITY’S DEFERRED MAINTENANCE PLAN.**

15           **(D) THE REPORT REQUIRED UNDER SUBSECTION (C) OF THIS SECTION**  
16 **SHALL INCLUDE:**

17           **(1) THE DOLLAR AMOUNT THAT THE ENTITY SPENDS PER SQUARE**  
18 **FOOT ON DEFERRED MAINTENANCE;**

19           **(2) THE TOTAL DOLLAR VALUE OF THE BACKLOG FOR DEFERRED**  
20 **MAINTENANCE;**

21           **(3) THE PROCESS FOR FACILITY CONDITION ASSESSMENT,**  
22 **INCLUDING THE PROCESS FOR RATING AND ASSESSING DEFERRED MAINTENANCE**  
23 **PROJECTS;**

24           **(4) THE NUMBER OF STAFF HOURS DEVOTED TO INSPECTING AND**  
25 **ANALYZING THE NEED FOR FACILITY REPAIR AND MAINTENANCE; AND**

26           **(5) THE ENTITY’S PLAN TO ADDRESS ALL DEFERRED MAINTENANCE**  
27 **PROJECTS.**

28           **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July**  
29 **1, 2020.**
